

Employment Advertisement No. 09/2016

Maharashtra State Electricity Transmission Company limited, a wholly owned corporate entity under the Maharashtra Government, was incorporated under the Companies Act, in June, 2005 after restructuring the erstwhile Maharashtra State Electricity Board to transmit electricity from its point of Generation to its point of Distribution. It owns and operates most of Maharashtra's Electric Power Transmission System. MSETCL operates a transmission network of 44,742 Circuit KM of transmission lines and 634 EHV Substations with 1,05,923 MVA transformation capacity. This infrastructure constitutes most of the inter regional as well as intra-regional electric power transmission system in the State. Today, MSETCL is the largest state transmission utility in the country. MSETCL has ambitious plan of its network expansion and invites applications for the following post:

- The Term "EHV" means 66 kv and above voltage level.
- The experience of a company having paid up capital of Rs. 100 Crores or more and having Power Transmission Business as its core activity / Central, State Govt. Power Transmission Utilities/any company which has obtained Licensee from respective State Electricity Regulatory Commission as Private Power Transmission Licensee shall only be considered. The experience certificate issued by Private Contractors, Proprietors, etc shall not be included as a Power Sector as well as Power Transmission experience. The experience certificate in respect of the company/organisation other than Central, State Govt. Power Transmission Utilities submitted by candidate shall be self explanatory i.e. in the experience certificate area / nature of work shall clearly be mentioned so as to enable to decide his / her eligibility and there shall not be any ambiguity for deciding their eligibility.

Note:

- i. A Degree should be from a University or Institute in India, established or incorporated under Central Act or a State Act or any other qualification recognized as equivalent thereto.
- ii. Equivalency of outside candidates will be compared / decided on the basis of gross emoluments drawn and job responsibilities.
- iii. The *experience means Post Qualification experience*, i.e. experience acquired by the candidate after possessing the essential qualification prescribed for the post.
- iv. The departmental candidates of MSETCL possessing Degree in Engineering/Technology in any other discipline and who fulfill the condition of required experience will be considered provided that they will have to appear for In-basket exercise, Group Discussion, etc. consisting of syllabus of Electrical Engineering and compete along with other candidates.

- The upper age limit for departmental candidates (only MSETCL Employees) is 57 years.

5. Methodology of Selection:

- i. Normally Competency Mapping Test will be conducted for selection process which will comprise of In-Basket Exercises, Group Discussion, Case Discussion, Presentation Skill and Personal Interview. However, which selection process is to be adopted will be at the absolute discretion of the Company and the decision of the Company in this regard shall be final.
- ii. All the candidates whose application received by 27.12.2016 will only be considered. Out of which who are apparently eligible as per age and educational criteria shall be called for first four tools of Competency Mapping Test viz. In-Basket Exercise, Group Discussion, Case Discussion and Presentation Skill without verifying their other eligibility criteria i.e. experience etc.

- iii. The candidates will be shortlisted for Personal Interview in the prescribed ratio taking into consideration their performance in the In-Basket Exercises, Group Discussion, Case Discussion and Presentation Skill as well as verification of their eligibility as mentioned in the advertisement.
- iv. The list of candidates shortlisted for Personal Interview will be displayed on the Company's website. Call Letters to such shortlisted candidates will be forwarded through E-Mail ID's mentioned in their application forms. No formal call letters shall be sent to the candidates at their postal address.
- v. Taking into consideration, overall performance reflected in all five tools of Competency Mapping Test viz; In-Basket Exercises, Group Discussion, Case Discussion, Presentation Skill & Personal Interview the final select list shall be prepared.
- vi. There will be cut off marks on overall marks (Competency Mapping Test and Personal Interview) as under:

- vii. The candidates who obtained marks equal or above the cutoff marks shall only be considered for selection.
- viii. The list of finally selected candidates will also be displayed on the website.

6. Application Fee:

- i. - iii. The Demand Draft submitted without CTS code will not be accepted and application may be rejected on the ground of non submission of application fees in prescribed manner.

- vi. Applications received after due date (for whatsoever reason) shall not be entertained. The Company is not responsible for postal delay or non-receipt of application within stipulated time. No correspondence in this regard will be entertained.
- vii. Incomplete application, application without signature & without Original DD are liable to be summarily rejected. Copies of certificates may be duly attested from the Government Gazetted Officer / Principal of Colleges / Post Master.
- viii. The departmental candidates of MSETCL may submit the copies of certificates duly attested from the officer not below of the rank of Superintending Engineer of MSETCL. They have to submit post wise experience certificate of MSEB/MSETCL duly signed by the concern authority of MSETCL.

- 1) Before filling up the application form candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement. Their admission to all the stages of the recruitment process will be purely <u>provisional</u> subject to verification and satisfying the prescribed eligibility criteria as mentioned in this advertisement.
- 2) Candidate must be **Indian Citizen.**
- 3) Pre-requisites are minimum and mere possession of the same does not entitle the candidate to be called for Selection Process.
- 4) Call letters for calling candidates for selection process will be forwarded through e-mail only on the email ID mentioned in the application form.
- 5) If the candidate knowingly or willfully furnishes incorrect or false particulars or certificates/documents or suppresses material information, the candidates will be disqualified at any stage of recruitment process and if appointed, shall be liable for dismissal from the Company's service without any notice or assigning any reasons whatsoever.
- 6) It is responsibility of the candidate to submit all the required documents/certificates for proving his/her eligibility.
- 7) It shall be sole responsibility of the candidate to prove his/her eligibility with respect to qualification, total experience, Specific experience, etc as required for the post applied.
