However, local journey charges shall not be reimbursed.*

Your candidature shall stand cancelled and you will not be allowed to appear for the personal interview, unless you produce all the required documents. **Candidates appearing for interview should ensure and satisfy all the conditions including QUALIFICATION & EXPERIENCE as notified in the Advertisement.**

4. At the time of interview the candidate should comply with the queries/deficiencies, if any, communicated to him in the interview call letter failing which he will not be allowed to appear for interview.

5. Any request for change of time, date and/or venue of the interview will not be entertained under any circumstances.
