

NOTIFICATION FOR INTIMATION OF RE-EXAMINATION (ON-LINE TEST) FOR THE POST OF "DEPUTY EXECUTIVE ENGINEER (CIVIL)" ADVERTISED VIDE ADVT. NO. 02/2016

Ref: - Notification dtd. 02.09.2016

Vide notification under reference, the intimation regarding cancellation of on-line tests conducted on **01.06.2016 to 03.06.2016** for the various posts advertised vide Advertisements 02/2016, 03/2016 (of Corporate Office, Mumbai) & 01/2016 of Zonal Offices was published & it was mentioned in the said notification that re-examination of the candidates who were appeared for the On-line test conducted on $1^{\rm st}$ June 2016 to $3^{\rm rd}$ June 2016 shall be conducted.

- 2. Accordingly, in 1st Phase, re-examination (On-line Test) of the candidates who had appeared for the on-line tests conducted on 01.06.2016 for the post of Deputy Executive Engineer (Civil) is scheduled on 01.12.2016. Other details, such as Reporting Time, Venue, Center, Instructions, etc. are given in the on-line test call letters.
- 3. The notification regarding re-examination of the posts of Assistant Engineer (Trans), Assistant Engineer (Telecom) and Assistant Engineer (Civil) shall be published separately.
- 4. **Links for downloading** on-line test Call Letter, On-line Mock Test, guidelines for persons with disabilities candidates using scribe, information handout and alfa order list of candidates called for on-line-test are given at the end of this notification. Candidates who had appeared for the on-line tests conducted on 01.06.2016 are requested to download their call letter and read it carefully before appearing for re-examination. For downloading of call letter candidates required to click on the link given at the end of this notification and enter their Registration Number and Password in the space "Existing User Login Here For Admit Card" caption. Also, copy of Call Letter being forwarded on registered email id of candidates.

- 6. All the candidates who had appeared for the on-line test conducted on 01.06.2016 have been called for re-examination (on-line test) without verifying their personal details viz. age, qualification, etc. Hence, before appearing for the on-line test, candidates must ensure that they fulfill the eligibility criteria stipulated in advertisement by the Company in all respects.

Instructions for appearing On-line Test:-

- 8. Candidates are informed to bring hard copy/print out of call letter alongwith currently valid Photo identity proof (as mentioned below) in original and a photocopy of the same ID proof, which is essential. The call-letter alongwith photocopy of photo identity proof duly stapled together is required to handover to the invigilator before starting of on-line test. Candidate's name as appearing on the call letter shall exactly match with the name as appearing on the photo identity proof.
- 9. The currently valid photo identity proof may be 'PAN Card/ Passport/ Driving License/ Voter's Card/ Bank Passbook with photograph/ Photo Identity Proof issued by a Gazzetted Officer on official letterhead/ Photo Identity Proof issued by a People's Representative on official letterhead/ valid recent Identity Card issued by a recognized

college/ university/ Aadhar card with a photograph/ Employee ID/ Bar Council Identity card with photograph'

- 10. **IDENTITY VERIFICATION:-** In the examination hall, the call letter along with a photocopy of the candidate's photo identity (as mentioned in 7 above) should be submitted to the invigilator for verification. The candidate's identity will be verified with respect to his/her details on the call letter, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the Examination.
- 11. **For Female candidates:** Their names as appearing on the Call Letter (provided by them during the process of registration) should exactly match with the name as appearing on the Photo Identity Proof. Female candidates who have changed first / middle / last name post marriage must take special note of this. If there is any mismatch between the name indicated in the Call Letter & Photo Identity Proof that female candidates will not be allowed to appear for on-line test.
- 12. Candidates reporting late for whatsoever reason i.e. after the reporting time specified on the call letter for Examination / Test will not be permitted to take the examination / test.
- 13. Candidates will have to appear for examination at Examination Centre at their own risks and MAHATRANSCO will not be responsible for any injury or losses, etc of any nature.
