- 2.2 The selected candidates are entitled to DA, HRA, Medical benefit, Leave Encashment, CPF, and Gratuity etc. as per Company's rules.
- 2.3 Those reserved category candidates who compete with the Open category candidates will be treated as Open category candidate for the purpose of recruitment/selection process.
- 2.4 The various concessions in the advertisement, for the candidates of SC/ST/VJ-A/NT-B/NT-C/NT-D/Spl. BC/OBC shall be applicable only to those who are domiciled in the state of Maharashtra and belong to SC/ST/VJ-A/NT-B/NT-C/NT-D/Spl. BC/OBC notified as such by the Government of Maharashtra and to other backwards classes recognized by the Government of Maharashtra on production of valid caste certificate from appropriate authority. SC/ST/VJ-A/NT-B/NT-C/NT-D/Spl. BC/OBC candidates of other states will be considered as belonging to unreserved category.
- 2.5 Once the caste is notified in application form, it cannot be changed at any stage later on.

3. Methodology of Selection:

- 3.1 The candidates will be shortlisted for selection process taking into consideration the qualification, experience, etc,
- 3.2 The selection process will consist of Competency Mapping Test/ Personal Interview as may be decided by the Management.
- 3.3 The list of applicants shortlisted for selection process will be made available on the website of the Company i.e. www.mahatransco.in . Similarly the list of finally selected candidates will also be displayed on the same website.
- 3.4 The recruitment in MSETCL is done strictly as per merit in a systematic way giving appropriate weightage to various selection tools.
- 3.5 Canvassing in any form will disqualify a candidate.
- 3.6 If any false/incorrect information furnished by the candidate is detected at any stage of recruitment process, his/her candidature will not be considered.
- 3.7 If the candidate knowingly or willfully furnishes incorrect or false particulars or suppresses material information he/she will be disqualified and if appointed, shall be liable for dismissal from the Company's service without any notice or assigning any reasons whatsoever.

- 3.8 The decision of the Company in all matters relating to recruitment shall be final and no individual correspondence will be entertained.
- 3.9 The selection of Departmental candidate will be subject to verification of disciplinary actions and vigilance enquiries in process/contemplated and other service records. The decision of the Company in this regard shall be final and no individual representation will be entertained.

- 5.1 Candidates belonging to Open category shall furnish Demand Draft/Pay Order of the value of Rs.600/- and candidates from backward class categories as per condition mentioned in 2.4 above, shall furnish Demand Draft/ Pay order of Rs. 300/- payable to the "Maharashtra State Electricity Transmission Company Ltd., Mumbai" drawn on any Nationalized Bank payable at Mumbai. The Demand Draft / Pay Order should have six months validity period.
- 5.2 The candidate should write his Full name, Caste & Post applied on the backside of Demand Draft/ Pay Order.
- 5.3 Fees in the form of Postal order/Money Order/ Cheque or any other form other than DD/ Pay Order will not be accepted.
- 5.4 In case selection process could not be conducted for any reason, the fees paid will not be refunded.

6 **Procedure to apply:**

- 6.1 Candidates applying for the posts advertised should ensure that they fulfill all eligibility criteria. Their admission to all the stages of the recruitment process will be purely provisional subject to satisfying the prescribed eligibility criteria mentioned in this Advertisement. The Company will take up verification of eligibility conditions with reference to documents submitted by the candidate only after the candidate has qualified for interview.
- 6.2 The candidates desirous of coming on deputation should send one advance copy of their application before due date and another copy should be sent through their organization.
- 6.3 This advertisement is published subject to the provisions of Maharashtra Civil Services (declaration of Small Family) Rules, 2005, prescribing declaration of the small family as one of the essential qualifications.
