- e) Caste Certificate (If applied against reserve category post)
- f) Caste Validity (If available - If applied against reserve category post)
- g) Non-Creamy Layer Certificate. {If applied against reserve category post (Except SC & ST) }
- h) Economically Weaker Section Eligibility Certificate (If applied against EWS reservation)
- i) Medical / Divyang Certificate (If applied against Divyang reservation)
- j) Discharge Certificate (If applied against Ex-serviceman reservation)
- k) Project Affected Person / Earthquake Affected Person Certificate (If applied against PAP or EAP reservation)
- l) Orphan Certificate (If applied against Orphan reservation)
- m) Sports Certificate (If applied against Sports reservation)
- n) Marathi Language Certificate (As mentioned in the advertisement)
- o) Change of Name Certificate (If applicable)
- p) Certificate regarding physical limitation in an examinee to write (if availed Compensatory Time in On-line Test)

5. If candidate remains absent for the Documents Verification then he/she may be held not interested and he/she will be held “Not Eligible” for further selection process.

6. Please take note that, calling for Documents Verification does not confer any automatic right of possible employment with the Company.

7. If it is required, provisionally wait listed candidates will be intimated separately. Hence, they are requested not to contact MSETCL office at present.
