

RESULT OF THE RECRUITMENT PROCESS OF GENERAL MANAGER (FINANCE AND ACCOUNTS) ADVERTISED VIDE ADVT. NO. 03/2023

- 1) Advertisement No. 03/2023 was published on 28.06.2023 for filling in the posts of General Manager (Finance and Accounts).
- 2) All the candidates who were apparently eligible as per pre-requisites mentioned in the advertisement were called for first four tools of Competency Mapping Test viz., In-Basket Exercise, Group Discussion, Case Discussion and Presentation Skill.
- Taking into consideration the pre-requisites as mentioned in the advertisement and based on overall performances reflected in all four exercises viz. In-basket Exercise, Group Discussion, Case Discussion & Presentation Skill, 6 candidates were short-listed for Personal Interview.
