Maharashtra State Electricity Transmission Company Limited (MAHATRANSCO), a wholly owned corporate entity under the Maharashtra Government, is incorporated under the Company's Act, in June, 2005 after restructuring the erstwhile Maharashtra State Electricity Board to transmit electricity from its point of Generation to its point of Distribution. It owns and operates most of Maharashtra's Electric Power Transmission System. MSETCL operates a transmission network of 52,292 (CKT KM) of Transmission Lines and 752 EHV Substations with 1,41,938 (MVA) Transformation Capacity. This infrastructure constitutes most of the inter regional as well as intra-regional electric power transmission system in the State. Today, MSETCL is the largest State Transmission Utility in the country.

The roles and responsibilities of Advisor (ROW), C.O., TBCB/Expert (ROW) field-TBCB:

- To assist Zonal CE for ROW resolution and completion of 400 Kv Saswad & 400 Kv Umred projects under TBCB in Pune & Nagpur Zone.
- To support & help in resolving severe RoW issues during construction of the various Transmission Projects in Pune and Nagpur zone and at Corporate level by coordination with local people, local representatives/land owners/farmers etc.
- To coordinate with railway/ NHSRCL/DFCCIL/ NHAI/ Private Industrial consumers if any for shifting of line works.
- To deal with large number of stake holders viz. forest, mangroves, CIDCO, railways/NHAI, Expressways, farmers, other electrical utilities etc. while working on the projects.
- To coordinate and liasoning with various department /section at Revenue Division/District/Sub-Divisional / Taluka level offices.
- To coordinate with the concern District Collector in those office, 16 (i) cases lodged, inform him about the importance of EHV lines under construction & request him for early passing of the orders.
- To coordinate with District Superintendent of Police to avail the police protection where the concern District Collector has issued the order under clause 16 (i) of Indian Electricity Act, 2003 & to take follow up right up to local police station for the same.
- To coordinate with Railway Authority i.e. concern divisional Railway Manager and below Authority to clear and approve the railway crossing proposal. Also to take follow up with Railway Authority to avail traffic and power block.
- To coordinate with concerned EHV Projects Division/Circle/Zone, MSETCL and discuss with him the nature, cause and action to be taken for resolving RoW issues of all ongoing EHV lines and to work in close association with concern SE, EE of MSETCL to limit the delay in execution of line.
- Assist to undertake a joint survey for the EHV line passing through forest as per Forest Conservation Act, 1980 along with officers of MSETCL and/or Assigned agencies and Forest Authority to estimate the forest involvement in the project. It will consist of enumeration of tress to the cut, detail route survey with land details (Sr. Nos, village, ownership documents, status of land etc.)
- After the completion of the surrey as per Dwellers Act, 2006, he will assist to ratify the
 proposals by all concerned Gram Panchayat so as to pass resolution regarding no
 involvement of rehabilitation of Adiwasis/ Tribals while ensuring no social injustice in
 meted to them from the project & this shall be with majority of more than 50% of total
 people affected.
- Regularly monitor the status of Forest proposal at all the level so as to speed up the proposal process.

- To coordinate with Revenue Officer to get the valuation order of concern affected land below the EHV transmission lines.
- Report the Chief Engineers (Projects / TBCB), C.O./Chief Engineers, Nagpur & Pune Zone/ Director (Project).
