## **CONDITIONS**

- 1) All vacancies notified as above are not to be filled in immediately. The select list is being prepared against the vacancies occurring during the year 2007 and 2008.
- 2) The number of vacancies and reservation for Backward classes and other reservation indicated for different categories is provisional and likely to change. Such change will not be notified either in Newspaper or intimated to the candidates.
- 3) Candidates applying for the posts advertised should ensure that they fulfill all eligibility criteria. Their admission to all the stages of the recruitment process will be purely <u>provisional</u> subject to satisfying the prescribed eligibility criteria mentioned in this advertisement. Company will take up verification of eligibility conditions with reference to original documents only after the candidate has qualified for interview.
- 4) While applying the post wherein experience essential, the candidates must attach a separate sheet showing the detailed experience such as name of Organisation/Company, designation/post held, nature of work, various places of working indicating specific period therein etc.

- 5) All candidates who pay the requisite Application Fees will be issued call letters. No detailed scrutiny of application will be carried out at the time of giving call letters for written test. The call letters will be sent by post at the correspondence address given by the candidate in their application form. Those candidates who do not receive call letter can down load the copy of the call letter from Companyøs website (<u>www.mahatransco.in</u>) and comply with the instructions given therein. Such candidates should also contact in charge of the Examination Centre one day before the date of Examination to get duplicate call letter.
- 6) Maharashtra State Public Services [Reservation for Scheduled Castes, Scheduled Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward category and Other Backward Classes] Act, 2001 has been enforced by the Govt. of Maharashtra from 29<sup>th</sup> Janauary,2004. As per provisions under sub-section 2 (ii) of Section-4 of this Act, the principle of Creamy-Layer has been made applicable to all categories except Scheduled Castes and Scheduled Tribes i.e. VJ(A), NT(B), NT(C), NT(D), SBC & OBC category. The candidates should produce a caste certificate from appropriate authority as prescribed by the Govt. of Maharashtra vide circular No CBC-10/200/PK 15/BCR15 dt 5/6/2006 showing that they are not covered under the concept of õ Creamy Layerö.
- 7) As per Government Resolution No.CBC-10/2003/PK91/BCR-5 dt. 8.12.2003, the candidates for claiming the benefit of reservation under SC, ST, VJA, NTB, NTC, NTD, Spl.BC & OBC categories, they should produce a caste certificate alongwith <u>caste validity certificate</u> issued by Caste Scrutiny Committee. The candidates applying without validity certificate of caste claim, if selected, will not be appointed unless their validity certificates are received within the validity period of select list i.e. within one year from the date of display of the Select list.
- 8) Those reserved category candidates who compete with the Open category candidates will be treated as Open category candidates for the purpose of recruitment/selection process.
- 9) The standards for the reserved category will be relaxed as per the Companyøs rules, if the required number of candidates are not available in any of the categories while short listing the candidates for personal interview and preparing the select list.
- 10) If sufficient number of persons with disabilities are not available on the basis of the general standard to fill all the vacancies reserved for them, candidates belonging to this category may be selected on relaxed standard to fill up the remaining vacancies reserved for them provided they are not found unfit for the post.

- 11)This advertisement is published subject to the provisions of Maharashtra Civil Services (Declaration of Small Family) Rules, 2005, prescribing declaration of the small family as one of the essential qualifications.
- 12)(i) The candidates will have to appear for Written Test. For the posts of Junior Engineer- õTraineeö (Post Code 01 ). Written Test will be conducted tentatively during the month of January 2008 at five centres viz.(1) Aurangabad (2) Mumbai (3) Nagpur (4) Nashik & (5) Pune. However, if the number of candidates desiring to appear for the Written Test at a particular place is not adequate, these candidates will be asked to appear for test at other center.
  - (ii) The Written Test for all other posts will also be conducted tentatively during the month of January **2008** at Mumbai.
- 13)The selected candidates for the post of Junior Engineer (Trans.)- Trainee (Post Code 01) will be appointed as Junior Engineer (Trans.)- Trainee. They will have to undergo the training for six months. During the training period the stipend will be paid at the rate of emoluments payable to the Jr.Engineer at the minimum of scale of pay of Rs.7075-310-8625-325-17075.On satisfactory completion of training the candidates will be appointed in the aforesaid pay scale.
- 14)The candidates will be short listed for Personal Interviews and group discussion tentatively to be held during the month of February/March 2008 on the basis of performance in the Written Test. Taking into consideration the performance in the written test & Personal Interview and group discussion, the select list will be prepared and the selected candidates will have to serve any where in Maharashtra in our Company.
- 15)The list of candidates called for written test, personal interview and group discussion and selected / unselected to the posts advertised will be published on the Companyøs website- www.mahatransco.in from time to time.

### **GENERAL CONDITIONS**

- (a) Prescribed qualifications are minimum and mere possession of the same does not entitle the candidate to be called for Interview. The candidates will be short-listed commensurate with the number of vacancies.
- (b) Knowledge of õMarathiö is essential.
- (c) In addition to basic pay, the selected candidates are entitled to DA, HRA, Medical Benefit, Leave Encashment, CPF and Gratuity etc. as per Companyøs rules.


