Implementation Method and Number of Beneficiaries – Segment-wise

- *Project was started with the base line in the form of Appeal Letter received from the Divisional Commissioner, Nagpur. Thereafter lot of deliberation took place with CSR Executive Committee then CSR Committee then finally with Board of Directors of the Company.*
- *In the deliberation an innovative idea was finalized by the management that to provide for Vaccination Vans which will reach to the un-reached Region of Vidarbha and also the vulnerable population like Pregnant Women, Differently Challenged, Old Aged, Bed Ridden, Comorbidities etc. of Vidarbha Region.*
- *To this idea a Detailed Project Report (DPR) was prepared by the Divisional Commissioner, Nagpur to which the administration and the management of the Company made needful changes and approved to sanction an amount of Rs.25 Crores for procurement of 200 Vaccination Vans with its sustainability plan in place.*
- *Beneficiaries - The vulnerable population like Pregnant Women, Differently Challenged, Old Aged, Bed Ridden, Comorbidities etc. of Vidarbha Region.*

Particulars of Impact Assessment Done

- Increased number of vaccinated population.
- Higher level of motivation among the Corona Warriors working in Health Department.
- Enhancement in Public Health Infrastructure, the Vaccination Van will be used all the time even after pandemic is eradicated.
- Solidarity towards the Government in the eyes of common public that Government extends helping hand to the public at large.
- Reaching to the un-reached and vulnerable population is the essence of the project.
- Community which was evading vaccination was becoming ready for vaccination.
