- A. General Pest Control Services & outdoor/indoor insecticide Spraying includes following.
  - 1. Pest control for Anti insect / bedbug treatment, anti reptile treatment & Rodent control treatment.
  - Outdoor / Indoor insecticides spraying for preventing Malaria, Dengue, Corona transmission & to control nuisance of Mosquitoes, termite, other insects and rats / mouse.
  - 3. The above all treatment in the area of 400KV Waluj substation Control room / Watchman Cabin premises & Residential Colony Quarters / Watchman cabin premises.
- B. Fumigation Treatment by using Canon plus includes following.
  - Fumigation treatment with Canon plus for controlling bugs, Mosquitoes, Files, Ants, Fumigation on garbage bins, Gutters, Garbage dumping area for preventing Malaria, Dengue, Corona transmission in 1<sup>st</sup> fortnight i.e. 1<sup>st</sup> 15 days of every month.
  - 2. The above all treatment in the area of 400KV Waluj substation Control room / Watchman Cabin premises & Residential Colony Quarters / Watchman cabin premises.
