TERMS & CONDITIONS:

1. Per month rates as per minimum wages act should be quoted include taxes & all other charges etc. excluding GST. No extra charges will be paid. Rates shall be quoted in words & in figures.

2. Your quotation should reach this office on or before date 27.10.2023 by 17.00 Hrs and the same shall be opened on the same day, if possible.

The order is limited to the period of 10 months from the date 01.10.2023 to 31.07.2024 or limited to amount 317762/- which ever is earlier

4. The work contract tax if applicable will be deducted from your bill as per rule.

5. The working hours will be normally from 09.30 Hrs to 18.30 Hrs or as per directives of undersigned.

6. According to the financial act, income tax will be deducted from your bill at the rate of rule of applicable of the contract value and certificate to that effect will be issued to you.

If any extra payment is required to be made by the agency to its employee on any account, the agency shall not have any right to claim additional payment from the company
