TERMS AND CONDITIONS:

- 2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- Submit the experience certificate along with work order for "providing and fixing of silica gel breather" at EHV substation in any power transmission utility in india.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer or equivalent. The bidder shall also submit the copy of the work order mentioned in the experience certificate as testimonials.

Commercial Bid.

- PAN Card of the firm/proprietor as the case may be. Income Tax return for last one year i.e. FY 2022-23(AY 2023-24).
- Certificate of Registration for GST with latest paid Challan.
- The bidder should have a valid Electrical Contractor's License issued by the Government of Maharashtra for work of erection/commissioning of EHV equipment.
- List of T&P available with the agency for execution of the work.
- Turnover duly certified by Chartered Accountant should not be less than 60% of the estimated cost during the F.Y 2022 23(AY 2023-24). Certificate issued by Chartered Accountant must have 15 digit UDIN (Unique Document Identification Number) if issued on or after 01.04.2018.
- Net Worth of last Financial Year 2022-23 (AY 2023-24) duly certified by Chartered Accountant (with UDIN) should not be less than 25% of estimated cost.
- The bidder should have to submit the audited financial statements i.e. profit & Loss account and Balance sheets for last financial year 2022-23(AY 2023-24) duly certified by Chartered Accountant with seal and UDIN.
- Shop Act License.

- 3. The Contractor rates should be in percentage (%) based on estimate cost.
- 4. Rates should be valid for 120 days from the date of commercial opening of RFx.
- 5. Rfx fee is Rs.118/- including taxes (Is nonrefundable).
- 6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 7. Income Tax will be deducted from contractor's bill, as per Govt. rules
- 8. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

9. Scope of work: -

 - ii) B.G. drawn in favor of MSETCL, Padgha.
