3. Quantities mentioned in Schedule 'B' are approximate and are liable for variations however payment will be made on actual quantities measured.
4. If the work is not completed within the stipulated time limit you shall be liable for penalty at the rate of 1% per month of the value of order or such smaller amount as Superintending Engineer may decide per delayed day, subject to maximum 5% of total cost of order. Application for extension in the time limit will have to be made in advance.
5. Quotations should be duly filled in all respects otherwise, it will not be considered.
6. In any dispute, decision of the Executive Engineer (C) M.S.E.T.C.Ltd, Civil Division Karad shall be final and binding on the contractor.
7. Rates should be quoted on percentage basis and as per Schedule – B inclusive of all taxes, such as Octroi, Royalties, Tolls, Good and Service Tax etc.
8. No material will be issued by the company for this work.
9. Bill in triplicate should be submitted to Addl. Executive Engineer (C), EHV Civil CCCM, Sub – Division Satara II after satisfactory completion of the work for arranging payment.
