- 8) As per provision of 'Mumbai Mudrank Adhiniyam, 1958 clause No.34' an agreement on appropriate value (Not less than Rs.500/-) of stamp paper shall have to be executed with MSETCL for execution of contract satisfactorily before engaging the vehicle. The amount of the
