1. Scope of work: -

 Total value of the Enquiry is Rs 4,97,525.48 (Rs. Four lakhs Ninety Seven thousand Five hundred and Twenty Five and Forty Eight Paisa only.) including GST.

 Rates: The rates quoted should on firm and inclusive of material required, T&P labour, Taxes and installation.

c) Contractor shall be required to pay the EMD amount Rs. 5000.00/- at EHV Project Circle Kalwa on refundable basis with quotation.

d) Shall be supply of various office chairs, cupboards, steel rack, table, etc as per attached schedule A herewith and the rates should be filled up for the particulars of work in Schedule – B. The work is to be carried out as per instructions of MSETCL concerned authority.

 Work Completion Period: Work should be completed within 30 days from the date of issue of LOA.

Bidder cannot sublet the work.

2. Security Deposit:

- a) Bidder will have to pay Security deposit at the office of Superintending Engineer, EHV Projects Circle. M.S.E.T.C.L., Kalwa or in the form of Demand Draft/Bank Transfer/FDR from of any schedule bank drawn in favour of "Superintending Engineer, EHV Projects Circle, M.S.E.T.C.L., Kalwa" only equal to 10 % of the value of the order and submit the same to this office within seven days from the date of receipt of work order. No interest will be allowed on this deposit. If on breach of contract during contract period, S.D will be forfeited without assigning any reason. The amount will be refunded after expiry of Guarantee period subjected to deduction, if any forfeited as per the terms and condition.
- b) Whenever there is paucity of funds, the priority of payments of bills of various agencies will be decided by the undersigned and all the rights in this regards are reserved with the undersigned and binding upon you. The contractor/Bidder is not entitled to claim any interest / compensation due to delay in their payments of bills on account of paucity of funds.
- c) The undersigned reserves the right to cancel the contract, after giving due notice to the contractor/Bidder, in the event of the breach of contract in any respect or undue delay in execution of work/starting of the work. - 8. Delivery Period: All the material will be supplied and installed within 05 days from the date of receipt of supply order. The material should be delivered as per Schedule -C Address at EHV Project Circle Kalwa office, EHV Project Division Kalwa office, EHV Project Division Kalyan office & their respective Sub-division offices as per as per instructions of MSETCL concerned authority. The specification of the material will be verified and approved by Executive Engineer /DyEE EHV Project Circle Kalwa well in advance before actual delivery. If the material not found correct as per our requirement, same will be rejected and you have to replace them free of cost. Accordingly work completion report to be collected from respective Division/Subdivision office after satisfactory delivery of material as per our requirement.
- 9. For more clarity regarding material to be supplied, it is requested to refer the images attached in the Tender Document. If the material not found as per approved sample, same will be rejected and you have to replace them free of cost, within 10 days from delivery of material.
- 10. Payment :100% payment will be made after satisfactory delivery of material at Circle Office and its respective division offices within, reasonable time period. The payment will be made by Cheque / RTGS at EHV Project Circle Kalwa.
- 11. Bill: The bill of work as per schedule 'A' should be submitted in triplicate along with advance stamped receipt at EHV Project Circle Kalwa after satisfactory completion of work. Guarantee of material is must with the bill. GST tax Reg. No. & Pan No. should be quoted on bill including supporting vouchers after supply of material in good conditions.

- Material Specification: Material should be supplied as per order specification & defect if any should be removed replaced at your cost.
- Company's Property: Any damage or loss to the Company's property due to your personnel negligence during the execution of the contract, you will have to make it good at your own cost.
- 17. Dispute: In case of any dispute arising out of your contract, it will be in the jurisdiction of Thane only.
- 18. T&P: All tools, plants & machinery required will have to be arranged by you free of cost.
- 19. Taxes, as applicable will be deducted from the bill.
- 20. Guarantee: In lieu of security deposit for Product Guarantee Should be submitted against quality of material & workmanship for 12 months and more from the date of completion of work.
