#### TERMS AND CONDITIONS:

- 1. Your sealed quotation should reach this office on or before Dt. 30.01.2025 at 18:15Hrs. and will be opened on the next day, if possible.
- 2. Quotation shall be sent under sealed cover duly super scribed as Quotation for -- -- & Your Enquiry No. -----
- 3. Documents enclosed with the offer for Technical Qualification.
  - a) Shop Act Registration
  - b) GST Registration Certificate.
  - c) PAN card of bidder with ITR 2023-24.
  - d)The bidder should either be a manufacturer of offered material or he should be an authorized dealer of the manufacturer. If the bidder is an authorized dealer of the manufacturer, he must submit documentary evidence such as an authorization letter from the original manufacturer for this E-Enquiry.

## In the case of the authorized vendor of OEM, the following clause shall be applicable.

a) In any E-Tender/ E-Enquiry, the same product/same model should not be quoted by more than 01 (one) dealer/distributor/channel partner. The OEM should authorize only one dealer/distributor/channel partner for a particular tender.

- b) In case, any OEM authorizes more than 01 (one) dealer/distributor/channel partner to bid in E-Enquiry & all the authorized dealers/distributors/channel partners bid for the same product/model, then the bids of all these authorized dealers/distributors/channel partners of said OEM shall be rejected in technical scrutiny itself.
- c) In case, if authorized dealer/distributor/channel partner participates in bid, then the OEM cannot participate in the same. Other way around, if an OEM participates in E-Enquiry, then his authorized dealer/distributor/channel partner cannot participate in the same E-Enquiry. Under such cases, bids of both OEM & its authorized dealer/distributor/channel partner shall be rejected in technical scrutiny itself
- 4. The rates shall be quoted in the work schedule "A" The rates and amount shall be written both in figures. The rates shall be written legibly and shall be free from eraser. Overwriting or conversions of figures correction and where unavoidable shall be made by Crossing out initiating, dating and rewriting.
- 5. No advance payment shall be made in any case. However, 100% payment shall be effected after satisfactory completion of work.
- 6. Security Deposit: -Security Deposit 10% of Order value to be paid within 10 days from the date of issue of LOA, in terms of cash/ DD to the office of Executive Engineer, EHV (O&M) Division Beed.
- 7. The quotation should be submitted strictly as per our requirement; any additional condition/shortfall left in offer letter shall cause rejection of quotation.
