Sealed firm quotations are hereby invited for the subjected works, as per details given in Schedule 'A', subject to following terms &conditions under EHV O&M circle, Chhatrapati Sambhajinagar

## **TERMS & CONDITIONS:**

- Your sealed quotations should reach this office on or before 25<sup>h</sup> March 2025 at 18:15 Hrs. & will be opened on next day, if possible.
- 3. Agency should have submit the attested Xerox copies of following documents :
  - a. RTO Tourist Permit certificate
  - b. Fitness certificate
  - c. Tax related certificate
  - d. Vehicle registration certificate
  - e. Valid Insurance certificate
  - f. PAN card of bidder
  - g. Driving Licence of driver
  - h. GST registration certificate if applicable
  - i. Shop Act
  - j. MSTCL's vendor number(if applicable)
  - k. & any other relevant documents of the vehicle to be provided on hired basis.
- 4. The rates shall be quoted in the work Schedule "A". The rates & amount both shall be written in figure. The rates shall be written legibly and shall be free from eraser. Overwriting or conversions of figures correction and where unavoidable shall be made by crossing out initiating, dating & rewriting.
- 5. No advance payment shall be made in any case. However, 100% payment shall be effected after satisfactory completion of work.

- 6. Security Deposit: Security deposits of 5% of order value to be paid within 7 days by Cash/DD to the office of Superintending Engineer, EHV(O&M)circle, Chhatrapati Sambhajinagar
- 7. If it is found that vehicle is not giving satisfactory service, the contract is liable for cancellation after giving 24 Hrs notice with the forfeiting of SD.
- 8. Driver should be managed by vehicle owner. He should have valid licenses to drive such type of vehicle and has the experience for driving such type of vehicle.
- 9. The quotation should be submitted strictly as per our requirements; any additional condition/shortfall left in offer letter shall cause rejection of quotations.
- 10. Only Diesel will be provided by MSETCL at the assured minimum average of 12km/L. If average is less than 12 km / L, the vehicle owner should bear the additional expenses on his account and the same charges will be deducted from the monthly bill.
- 11. The vehicle should be in good running condition. Also, the model of Vehicle which is being hired shall be latest and in any case it should not be more than five years old.
- 12. In case of failure/maintenance of vehicle you will have to provide another vehicle on same term &conditions and rate. If duration of this type of failure/maintenance exceeds 10 days then the contract may get terminated with the forfeiting of SD. If you fail to make such arrangement, department shall make the arrangement at your risk & cost.
- 13. Any dispute/differences arise, will be subjected to jurisdiction of Chh.Sambhajinagar.
- 14. The working hours normally from 08:00 to 20:00 Hrs. or as per directive of Addl.Executive Engineer, Hot Line Unit,Chhatrapati Sambhajinagar. However vehicle will be under MSETCL service for 24 Hrs. The use of vehicles will be as per instructions of Addl.Executive Engineer,Hot Line Unit, Chhatrapati Sambhajinagar.
- 15. Order value is limited to each month of Rs. 50,000/-( Including fuel and Hiring charges with service tax)
- 16. All payments such as penalty of RTO, wrong parking penalty should be borne by you.
- 17. Vehicle should be on the name of contractor. All the documents related with the vehicle should be on the name of contractor.
