TERMS AND CONDITIONS:

1. The EMD and Tender fees is to be paid online on the account of MSETCL through website https://srmetender.mahatransco.in. Due Date- 05.05.2025 upto 10.00 Hrs.

2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

• Submit the Performance/Experience certificate along with work order for the AMC of Air conditioners at any Government/Private Organization in India.

Commercial Bid.

- PAN Card of the firm / proprietor as the case may be.
- Income Tax Return for last financial year.
- List of T&P available with the agency for execution of the work.
- Certificate of Registration for GST with latest paid Challan. (if applicable)
- The bidder should have the Minimum Annual Average Turnover (MAAT) of at least 60% of tender estimated cost in the last three years i.e. 36 months.
- Net Worth of last Financial Year 2023-24 duly certified by Chartered Accountant (with UDIN) should not be less than 25% of estimated cost.
- The bidder should have a valid Electrical Contractor's License issued by the Government of Maharashtra for work of erection/commissioning of EHV equipment.
- Shop Act License.
- 3. The Contractor rates should be in percentage (%) based on estimate cost.
- 4. Rates should be valid for 120 days from the date of commercial opening of RFx.
- 5. Rfx fee is Rs.118/- including taxes (Is non refundable).
- 6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 7. Income Tax will be deducted from contractor's bill, as per Govt. rules.
- 8. **Warranty** : 'The Contractor' will have to give a warranty / guarantee for material supplied for the period as specified by the manufacturer/OEM of the material from the date of receipt of material at site / work place as the case may be. The warranty certificate should be given along with the material. If the OEM warranty is less than One year the bidder shall give warranty of at least one year from the supply of material.

- 9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
- Scope of work:
 - a) Regular Servicing of all AC units & cleaning of filters and coils as per the agreed schedule & periodic preventive maintenance. Also, inspection of refrigerant levels.
 - b) Immediate response and repair of any breakdowns & repair and replacement of parts (if required).
 - c) On-call emergency repair services.
 - d) Comprehensive report of maintenance activities and recommendations.
- 10. Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company in the approved proforma on stamp paper at your cost as per the D.O. ltr no. Mudrank- 2009/2707/Pra.Kra./326/M-1 dtd 09.10.09, Co.'s Adm. Circular no. 207 dtd 17.04. 10 & as per the Maharashtra ordinance No. XII on dtd. 14.10.2024. Until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, for the work executed under the contract.
 - 11. You have to pay the security deposit of amount equal to 10%(Ten) of the order value within 07 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (0&M) Circle, Padghe, Tal. Bhiwandi, Dist. Thane, Demand Draft or equivalent Govt. Securities or Fixed Deposit Receipt or RTGS.
