Terms & Conditions: -

- 1) Scope of Work: Details of work is as per Annexure 'A' enclosed herewith.
- 2) **Period:** The period of the contract shall be one year.
- 3) Security Deposit: You will have to pay security deposit amounting 5% of the value of the order within 15 days of receiving order which will be refunded to you after satisfactory execution of the order. In the event of unsatisfactory performance of the contract, or noncompliance to T&C this amount will be forfeited.
- 4) **Payment:** Payment will be made on quarterly basis on submission of bills in duplicate.
- 5) Validity: You offer shall be valid for at least 60 days.
- 6) If any loss occurs to MSETCL property during execution of works, you should make it at good at your cost.
- 7) The work shall be carried out by modern practices such as Rattraps & good quality dusters, detergent material etc. Air freshener, are to be provided by the contractor.
- 8) Workmen engaged in the work will be subject to security check and this office will not be responsible for any kind of accident while carrying out works and no compensation will be paid by the MSETCL.
- 9) The undersigned reserves the right to cancel any or all the quotations without assigning any reasons thereof.
- 10) If any dispute arises, the decision of the undersigned is final & binding on you.

- 11) The order is liable for cancellation at any time during the contract period if the work is not found satisfactory and you will liable to compensate the loss because of the cancellation of order.
- 12) Following documents need to be submitted along with the quotation i.e.
 - i) Copy of PAN Card.
 - ii) Certificate of registration / MSME / intimation under Maharashtra Shops & Establishment Act 2018 if applicable.
 - iii) GST registration certificate if applicable
 - iv) Valid license to sell, stock or exhibit for sell or distribution of insecticides.
 - v) Similar type of work experience for controlling Rodent (Rats) & Pest control costing not less than the amount equal to 40% of estimated cost. The order value not less amounting Rs. 33,252/- executed during any one of previous five financial years.
