Sealed and super scribed quotations are invited for the above work, so as to reach this office on or before Dt. 30.05.2025 upto 15.00 Hrs. You are requested to quote your reasonable rate for the above work. The terms and conditions are as follows.

The offer should be submitted in two separate sealed envelopes contained in one main envelope super scribing the subject.

Envelope 1: Should contain associated documents/Certificates/proof of qualifying prerequisite Broachers attested certificate etc such as,

- 1.GST Registration Certificate
- 2.PAN Card
- 3. Valid Registration under shop and establishment Act or NOC of grampanchayat for shop .
- 4.The bidder should have a valid Electrical Contractor's License issued by the Government of Maharashtra
- 5. a) The bidder should have an experience as a contractor in the execution of works of similar nature and complexity to that required under this contract. Such works should include in last 5years design, supply, erection, civil works, testing and commissioning of transmission and/or distribution systems, comprising of lines, underground cables, substation, transformers, augmentation of transformers and allied works particularly in MSETCL /MSEDCL/Govt. Institution during last 5 years minimum (previous to the submission of quotation).
- i) One work order for work mentioned above, with completed work cost not less than the amount equal to 80% of the estimated cost.

OR

ii) Two work orders for work mentioned above, with completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

- iii) Three work orders for work mentioned above, with completed works each costing not less than the amount equal to 40% of the estimated cost.
- (b) The Work done / Performance Certificate against said work orders from Authorized Person / Competent Authority (not below the rank of Executive Engineer) should be submitted along with respective work order copies.

Note: For period of experience, last 5 years as the case may be, should be ending on start date of floating this Enquiry.

- 6. The average annual turnover of the bidder during last three financial years should be not below than 60 % of estimated cost.
- 7. The bidder should have a Net Worth (which is defined as "Equity share capital + Reserves- Revaluation reserves Intangible assets Miscellaneous expenditure to the extent not written off and carry forward losses") of not less than 25% (Twenty-Five Percent) value of estimated cost of tender offered. The bidder should submit the statement of Net worth duly certified by Chartered Accountant for the last financial year ending.
- 8. Income Tax Returns: The Bidder shall submit the copy of Income Tax returns for the last three Financial years.
- 9.Bidders will have to submit an undertaking as per 'Annexure-G' format(Format of is enclosed with this Enquiry document).
- 10. A declaration to the effect that the bidder does not anticipate change in his ownership during the proposed period of the work till successful completion of warranty period (if such a change is anticipated, the scope and effect thereof, shall be defined) shall be submitted with the offer.
- 11. Joint Ventures will not be allowed.
- **Note:-** * If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

 - *All CA certified certificates should have UDIN as per ICAI guidelines. Documents without UDIN are liable for rejection.
 - *If quotations are called between 1st April & 30th September of the year, then latest audited financial year shall be a year before previous year for financial criteria. For the quotations called after 1st October then the latest audited financial year shall be the previous financial year of current financial year.
 - * Apart from the above, the undersigned reserves the right to condone any condition or may request for submission of any additional documents as well as original copies of the above documents for verification, if required, before the opening of the price bid.
 - *The supplied material should be as per MSETCL T &C and Technical Specification(Visit MSEDCL Website for latest technical specification of Equipment)

- 1) After verifying full documents /certificated pre-qualification as above in envelope 1,if it is found that ,bidder fulfills the desired prerequisites, then only envelope 2. will be opened. If the same is not meeting the prerequisites, Envelope 2 shall not open.
 - 2) Quotations with incomplete details submitted without sealing or superscripting not submitted in prescribed format etc are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible for delay in postal transit. The agency should not submit 'conditional quotation' such conditional offer shall be liable for rejection.
 - 3) The right to place an order for part or to cancel any or all quotations without assigning any reasons is reserved with this office.

TERMS AND CONDITIONS:

1) Contract Price:-

- 2) AGREEMENT: Within 07 days from the date of receipt of the LOI, the contractor shall enter into an agreement of Rs. 500.00/- with the MSETCL. The cost of stamp paper is to be borne by the contractor. After submission of agreement, the contractor will be called for scheduling the date of signing & execution of agreement in the office of Executive Engineer, EHV Projects Division 1, Pune. Until the agreement is executed, the MSETCL will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor
- 3) **SECURITY DEPOSIT:-** The contractor will have to pay Security Deposit of 10% of the work order value within 7 days from the date of receipt of LOI in the form of FDR/B.G of any Nationalized/ scheduled Bank in the favour of "MSETCL" at the office of The Executive Engineer, EHV Projects Division-I, Pune valid for one year or online payment NEFT/RTGS. . If you fail to do so, the security deposit along with interest @ rate of 18% per annum or part thereof will be recovered from your first bill. The Security deposit will be refunded only after satisfactory completion of the Guarantee period. Also, you will have to apply for refund of SD within 6 months after completion of guarantee period. If you fail to apply within stipulated period, the action as per CO's rules will be taken
- **4)** Rate Validity: The offer shall be valid for acceptance for a minimum period of 60 days from the date of submission of the offer. During this period no bidder shall be allowed to withdraw his offer. Such withdrawal during the said period shall result in the forfeiting of SD.
- 5) The rate in % should be quoted on firm quotation basis. Rates should be inclusive of all taxes & duties.
- **6**)The Schedule "A" duly filled in with the rates quoted as percentage above/below / at par of our estimated rates will be submitted by registered post or in person to the Office of the Executive Engineer, EHV Projects Division-I,Pune
- 7) **SUPERVISION OF WORK:-** The work should be carried out under the supervision of the Additional Executive Engineer, Substation Project Sub-division, Baramati. The work should be executed as per instructions from the Additional Executive Engineer, Substation Project Sub-division, Baramati who will supervise the work. The work carried out without supervision will not be recorded and payment will not be released for such works which may please be noted.
- **8) SCOPE OF WORK:** Work of Supply, Erection, Testing and Commissioning including civil work for providing 11kV, 3 phase auxiliary A.C. power supply at Mudhale SS.

Note-.

The prior permission from the concerned Engineer-in-charge is to be taken by the Contractor before starting the work.

- **09) WORK COMPLETION PERIOD:** The work should be completed within 3 months from date of handing over of site/15 days from last outage whichever is later.
- 10) The Contractor shall guarantee/warranty that the materials will be new and in accordance with the contract documents and will be free from defects in material and workmanship for a period of Twelve (12) Month from the date of final acceptance of the entire scope of work/project by the Owner. Any defect developed due to defective materials and/or workmanship during testing and commissioning / performance of the works executed or during the guarantee/warranty period of Twelve (12) Month from the date of final acceptance of the entire scope of work/project by the Owner shall be rectified or made good by the Contractor at his own cost. The Contractor's liability shall be limited to repair / replacement of any defective part in the equipment of his own manufacture or those of his sub-contractor and arising from faulty design, materials and/or workmanship. All costs for the repair and/or replacement of defective parts such as dismantling, re-erection, supply, transportation etc. shall be to the account of Contractor. In case of failure after the guarantee period but before the estimated life of equipment, punitive actions deem fit will be initiated. The respective guarantee/warranty should be as mentioned in respective technical specifications of equipment's in Book II.
- 11) Contractor shall produce guarantee certificate by the manufacturer /supplier for a period of 2 years (Minor Material) & 5 Years for Major material.

12) Packing/ Handling & Transportation of material:

- a) The Contractor shall be fully responsible for Packing, Forwarding and Transportation of material by any other authorized mode of transport, clearance of equipment and further transportation of site place to of work / storage yard etc., in respect of material in his scope.
- b) Contractor shall pack and crate all material in such a manner as to protect them from deterioration and damage during rail / road or any other authorized mode of transfer. The contractor shall be held responsible for all damages / losses.
- c) The contractor shall notify the Owner of date of each shipment from his / manufacturer works. The contractor shall give all shipping information concerning the weight, size and the contents of each packing including any other information the owner may require.
- 13) Inspection of the works: The site incharge will act as operating officer for this work. The works shall be under the overall supervision and shall be subject to the approval of the Executive Engineer or his designated representative. All the Material supplied must be of standard quality & duly checked by operating officer as per required specification. The work carried out without supervision will not be recorded and payment will not be released for such works which may please be noted.
- **14) QUALITY OF WORK:** The contractor will be responsible for quality of work & workmanship. The contractor should supply material from approved vendor only.
- **15) VARIATION IN QUANTITIES OF WORK:** The work will be generally carried out in accordance with the instructions given at site. The Executive Engineer, EHV Projects Division 1, Pune or his representative reserves right to increase or decrease the quantities of work to be executed or deleted or add any items, part or whole thereof. The payment will be done for the actual quantity of work done.

16) FAILURE OF EXECUTION OF THE WORK: For failure to execute the work as per given schedule against the order in part or full, within the stipulated period, the Company shall be at liberty, without further notice or reminder to the contractor to get the same work done on account of and at the risk & cost of the contractor and claim for the difference in price and for all expense whatsoever incurred in getting the said work done and the same shall be recovered from any payment due to the Contractor from bills or deposit or on any account with any MSETCL's Offices, such expenses will also include 15% Supervision charges & Security Deposit will be forfeited.

17) PENALTY:

- a) **Performance of work:** If it is found that performance of work is unsatisfactory, or not as per norms of MSETCL, the contract is liable for termination at any stage of work without giving any prior notice and at contractor's entire risk & cost. The security deposit paid by the contractor shall be forfeited in that case.
- **b) Delay in execution of work**: In case of delay in execution of work beyond work completion period, penalty @ ½ % per delayed week, maximum to 10% of order amount shall be levied on contract value. If the work is not carried out in the stipulated period, the works will be got done departmentally or through any other agency at your risk and cost even at higher rates, in addition to the penalty that shall be chargeable as mentioned above.
- c) Penalty for partly completion of work: In case the contractor fail to complete the work entrusted, partly or fully, the balance work will be carried out through other agency and difference in cost will be recovered from contractor's bill and S.D. & the over & above balance shall be recovered from contractor or else penalty will be charged, maximum up to 10 % of order value whichever is higher.

To impose penalty in above (a), (b) & (c) case, for execution of work is discretion Engineer Incharge of EHV Substation Project Sub Division under EHV Project Division 1, Pune with due justification.

- **18) SUBMISSION OF BILLS / PAYMENT OF BILLS:** The tax invoice/ if applicable E-Invoice along with Guarantee/ warrantee Certificate and MRC/JMC signed by both parties & advance revenue stamp receipt should be submitted in triplicate to the Addittional Executive Engineer EHV Substation Project Sub Division Baramati. Please quote PAN No. on the bill with bank details for RTGS/ NEFT Payment. The service entry of the bills will be done by concerned incharge in SAP. Scrutinizing & auditing will be done at Division Office. Payment will be effected within reasonable time & as per availability of funds at Division Office.
- 19) RISK & COST: MSETCL does not take any risk and will not pay any compensation for fatal/ non-fatal accidents to persons deployed by the contractor for the work, while carrying out the work under contract nor anything will be paid towards damages to the contractor vehicle/T&P etc. If any accident occurs to any of worker/ Supervisor/or outsiders during the work, the same will be on the contractor's account & if any expenditure is done towards medical aid that can be recovered from the contractor bill. MSETCL will not be responsible for such accident/ compensation payment etc.

The works whether fully completed or incomplete, all the materials, machinery, T&P temporary building, and other things connected therein shall remain at the risk and in the sole charge of the contractor until the completed work has been handed over to the Engineer In-Charge and till completion certificate has been obtained from the Engineer In-Charge. Until such handing over of the completed work, the contractor shall at his own risk &cost take all precautions reasonably necessary to keep all the aforesaid works and other things connected therewith, free from any loss or damage. In the event of the same or any part thereof being lost or damaged, he shall reinstate and make good such loss or damage, at his own cost & risk.

20) INSURANCE AND PAYMENT OF CONTRACTOR PERSONNEL: Personnel employed

by the contractor for execution of this contract shall be under Workmen's Compensation Act as required under the relevant provisions of the Contract (Labour/ Regulation and Abolition) Act 1979. It is whole responsibility of the contractor.

- 21) SAFTY: The contractor should ensure the safety of all the workmen, materials and equipment at work site. The contractor will be responsible for providing of all safety notices and safety equipment required. M.S.E.T.C.L will not be responsible for any accident or damages thereof due to contractor's worker's negligence on non-observance of our instructions. The contractor has to bear the compensation to their worker's in case of any accident.
- **22) IDLE LABOR HOURS:** In case of suspension of work, or delay in work, non-sanction of outage due to any reason or stay order of the Court of Law no compensation will be paid by the Company for idle labors /idle machinery etc., for that period.
- **23)** Any breakage/damage occurred to MSETCL material/ Equipment / theft of material if any, asset during the work shall be recovered from the contractor bills as per rules.
- 24) The contractor will not be entitled to claim any interest on amount payable to them.
- **25) LOSS OF MATERIAL:** The contractor will have to keep their material in their safe custody. MSETCL will not be responsible for the loss of the material kept at MSETCL's site. The accommodation for the contractor's staff shall not be provided by the MSETCL.
- **26) TOOLS AND PLANTS:** All kinds of Tools, plants, Tackles and machines etc., are to be arranged by the contractor at their cost. Company will not spare anything on this account.
- **27) HOUSING & ACCOMMODATION:** The contractor will have to make their own arrangement for the housing of their staff and labors.
- **28) SITE CLEARANCE:** The contractor should, during the progress of work, keep the site reasonably free of all unnecessary obstruction and shall store the material neatly so as not to cause any obstruction for normal working / operations.
- **29**) In case of any conflicting instructions or any difference of opinion about any point or in case of any dispute about this Enquiry specification/contract/ work order for interpretation of any of the clause/terms conditions of this contract, the decision of the Executive Engineer, EHV Project Division 1, Pune about the interpretation of any terms and conditions will be final and binding on the contractor.
- **30) TERMINATION OF CONTRACT:-** The undersigned reserves the right to accept or reject the Enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days without assigning any reasons, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.
- **31) TAXES:-** Income Tax & all other applicable taxes will be deduced as per prevailing rates from the contractor's bill, as per rule, if applicable. GST Number should be mentioned on the bill.
- **32**) Variation in taxes & duties if any shall not be payable.
- **33) HINDRANCE OF WORK:-** If the work has to be suspended due to any reason, shut down etc., the MSETCL shall not pay any compensation/ damage to the contractor towards items like labor, idle machinery, vehicle etc. however in such cases the contractor will be paid for the actual work executed by them under the supervision & measured by concerned engineer.

- **34) SUB-LETTING OF CONTRACT:** The contract or any part thereof shall not be assigned, transferred, or sublet.
- **35) Force Majeure:** Only the following conditions shall be considered for the purpose of this clause.
 - a) Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc.
 - b) Acts of any Government, Domestic or Foreign such as war (declared or undeclared
 - d)Priorities, Guarantees Embargoes etc.
 - c) The party affected by 'Force Majeure' shall within 15 days of the occurrence of such a cause, notify the MSETCL in writing with sufficient documentary proof.order of the Court of Law **no** compensation will be paid by the Company for idle labours /idle machinery etc., during the period.
- **36) APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:** All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding supply and work, which are not stated here, are also applicable to this contract.
- **37) JURISDICTION:** All disputes or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE Court only.
- 38) Prohibiting participation of Bidders:- Debarred / Blacklisted by Government / Semi Government / Other Power Utilities: Bidders will have to submit an undertaking as per 'Annexure-G' format, declaring that their Firm is not Debarred / Blacklisted by any Government / Semi Government / Other Power Utilities / MSETCL, anywhere. If it is revealed that the participating Bidder is Debarred / Blacklisted by any Government / Semi-Government / Other Power Utilities / MSETCL, anywhere, the Offer of such Bidder shall be liable for rejection at any stage of the Tendering process. Further, if it is revealed that the successful Bidder is Debarred / Blacklisted by Government / Semi Government/Other Power Utilities / MSETCL, anywhere, then Order of such Bidder shall be liable for termination at any stage of Order execution process and the concern Bidder shall be solely responsible for the consequences arising there from.
