The LOA/work order will be placed on final accepted price for (Supply + ETC) works including GST & Duties.

Price Variation i.e. PV on Taxes & duties if any will not be payable.

For extra quantities if any, rate shall be as per approved MSETCL SOR for the year 2022-23 or as reasonable.

Bidder should submit the all Schedules duly signed and filled with relevant information
