Subject: E-enquiry for inviting quotation for providing of Diesel Sumo gold/Long Bolero/Xylo/Scorpio or equivalent vehicle on hiring basis for 400 KV Dhule Babhaleshwar Line Maintenance Sub-Division under 400 KV R.S. (O&M) Dn. Dhule as per enclosed Schedule 'A'.

Dear Sir,

Sealed and super scribed quotations are invited for the above work as per enclosed schedule 'A'. You are requested to quote your lowest rate for the above work. The terms and conditions are as follows.

**TERMS AND CONDITIONS:**

1. Per day rates quoted should include provision of Driver, his salaries & allowances, Vehicle maintenance, Taxes, and all other charges etc. excluding GST Tax. No extra charges will be paid other than quoted rate by MSETCL. The rate shall be quoted in words and figures.
2. Bidders should strictly follow norms & safety measures prescribed by RTO.
3. Your quotation should reach this office during office days on or before **dt.06.06.2025 upto 15:00hrs** and same shall be opened on next day, if possible.
4. The order is limited to the period of one year or exhaust of work order amount (including all taxes) from the date of engaging the vehicle.
5. **Fuel consumption for the vehicle considered at the assured minimum average of 12 kms/ ltr.** The same shall be reimbursed as per prevailing market rates for actual running of vehicle for company's use as and when required. If average goes below than that the vehicle owner should bear the additional expenses on his account and the same charges will be deducted from the monthly bill.
6. The work contract tax if applicable will be deducted from your Bill as per rule.
7. The Company will not be responsible for any kind of accident or damages to the Vehicle or driver during the hired period. All the financial liabilities arising out of accident shall be borne by the providing Agency/Owner of Vehicle.
8. The working hours will be normally from 07.00 Hrs. to 19.00 Hrs. or as and when required as per directives of undersigned.
9. Any kind of Vehicle breakdown should be attended by providing Agency. No charges will be paid by Company during breakdown. Vehicle Agency/Owner will have to provide alternate Vehicle during breakdown at same rate.
10. According to financial act, income tax will be deducted from your bill & certificate to that will be issued to you.
11. The rate quoted should be firm & price variation will not be acceptable. Rate should be inclusive of all taxes & other incidental charges.
12. Driver should be managed by Vehicle providing Agency. He should have valid license to drive such type of vehicle and has the experience for driving such type of vehicle. Driver should not have any criminal record & NO FIR should be registered against him. Driver should not found under influence of any type of alcoholic drugs during working hours. Driver shall be paid by the Agency according to the Minimum Wages Act & it is the whole responsibility of the Agency, MSETCL will not entertain claim/dispute arises for the same.
13. All the Rules regarding registrations of vehicle, Sales Tax, GST Tax & other Govt. Taxes etc. should be borne by Vehicle providing Agency.
14. All payments such as penalty of RTO, wrong parking penalty should be borne by you.
15. If it is found that vehicle is not giving satisfactory service, the contract is liable for cancellation after giving 24 Hrs. notice.
16. **Security deposits:** The You have to pay a security deposit of 10% of the order value for this work with MSETCL in the form of FDR/D.D./BG of any Nationalized/scheduled Bank in the name of

- 'M.S.E.T.C.L., Dhule', payable at Dhule. Having validity for one year. The security Deposit to be submitted before starting of work. The security deposit will be refunded on demand only after satisfactory completion of contract.
17. The validity of your work order will be for one complete year from the date of issue of order or Exhaust of work order amount from the date of engaging the Vehicle.
  18. All Terms and Conditions as per Company's Rules including those work in the M.S.E.T.Co.Ltd. booklet. "Tender and contract for works" are applicable in this case also. Not with standing stated herein, the Company's General Terms and Condition of contract shall be applicable to this contract also.
  19. Undersigned reserves the right to accept any Tender or to reject/accept all the Tenders without assigning any reason.
  20. Any dispute/differences arises, will be subjected to jurisdiction of **Dhule court** only.
  21. The Vehicle providing Agency/Owner if wants any clarification regarding working of Vehicle or any Terms Condition, he should approach in writing to undersigned before quoting the rates.
  22. After due date no clarification will be given and the decision of undersigned will be final and binding on all the Vehicle providing Agency/Owner quoting for said work.
  23. The work shall be supervised by the Engineer, appointed by under signed and it should be carried out to the satisfaction of Engineer In charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
  24. Liquidated Damages / Loss due to theft: - Any damage or loss to M. S. E T. Co. Ltd.'s property due to your employees/workers/driver's negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.
  25. The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee/driver during the course of contract. Contractor/Agency/Owner will have to provide safety equipment's to his employees. Contractor/Agency/Owner will be solely responsible for compensation or medical treatment etc. for all the liabilities arising out of such accident.
  26. Bill payment will be paid to you by account payee Cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in SAP-SES.
  27. M.S.E.T.Co.Ltd. Ltd. reserves rights to add more terms during the contract period if found necessary.
  28. The said Vehicle should not be owned by Company's employee/his nearest relatives.
  29. After due date no clarification will be given and the decision of undersigned will be final and binding on all the Vehicle providing Agency/Owner quoting for said work.
  30. The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of breach of contract in any respect or under delay in execution of work.
  31. Penalty: - in the event of service not provided /satisfactorily the contractor shall be liable to pay the penalty as ½% per day and maximum of 10% of total value of contract.
  32. If the tenderer fails to provide the service on time, it will be treated as breach of contract & contract will be terminated & order will be cancelled and forfeiting the S.D.
  33. You should have to execute the agreement on stamp paper of Rs. 500/- at your own cost as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with requisite stamp duty immediately after the payment of security deposit.

### **Instructions to Tenderer**

34. The tenderer duly filled in should be sent in a cover properly sealed and super scribed as shown below in person only to Executive Engineer 400KV RS Division, Dhule so as to reach not later than due date. The cover should be super scribed with name of work and tender No.
35. The said Vehicle should not be owned by MSETCL company employee/his nearest relatives.
36. Driver should be managed by Vehicle providing agency. He should have valid license to drive such type of Vehicle & has experience for driving such type of Vehicle.
37. Only one envelope for tender filled in & for all documents of Vehicle such as: -
  - a) Documents of Vehicle such as RC/TC book, make, model, capacity of Vehicle, RTO Vehicle T-permit, PUC Certificate, insurance, fitness certificate.
  - b) PAN no. copy should be submitting.
  - c) Proof regarding registration under GST or If not applicable then undertaking regarding that.
  - d) The vehicle should be in good condition **having manufacturing year of preferably 2020 or onwards**, after due physical verification by concern S/Dn. Incharge.

38. While submitting the tender, the Tenderer must fill in tender form/specification and schedule 'A' of rate. The rate should be quoted both in words & in figures.
39. The tender documents shall be written legibly and shall be free from eraser, overwriting or conversions of figures correction and where unavoidable corrections in the tender and particularly in rates must be signed and dated by the Tenderer and all pages should bear the initials of the Tenderer at the bottom of each page.
40. **Tender Fee: Rs.100/-** will be the tender fees to be paid before or while submitting the quoted bid within due date.
41. The Maharashtra State Electricity Transmission Co. Ltd. or its officer who accepts the tender shall have the right to reject any or all the tenders in part or full and will not be bound to accept the lowest nor to assign any reason what-so-ever for such rejection/acceptance.
42. The Tenderer is supposed to obey all the Rules of R.T.O. & M.S.E.T.Co.Ltd. during the course of contract. Failure to obey the rules is liable for termination of Contract with all responsibilities with the Tenderer.
43. The contract can be terminated by the undersigned authority at any time, without assigning any reason thereof.
44. The submission of tender by tenderer implies that he had read all Instructions and Conditions of contract & he had made himself aware of scope & specification of work to be done.
