Terms and Conditions:

- 1) Due Date: The quotations complete in all respects, dully sealed & super scribed should be submitted to this office on or upto dt.09.06.2025 upto 18:00 Hrs.
- 2) Documents required: PAN/ TAN registration certificate, Valid GST registration certificate, Proof of firm being registered as shop establishment/firm/ Company as applicable & Authorization certificate from original manufacturer (i.e. Eureka Forbes) & Proforma Annexure-G.
- 3) Quality: Original, Good & genuine parts only utilized for above work. Contract will be terminated without prior notice at any stage, if faulty/duplicate spare found utilized.
- 4) Scope of work: The work involves Replacement of filter cartridge & servicing of Dr. Aquaguard Magna RO & UV purifiers. The agency should have experienced & qualified staff to carry out the replacement work.
- 5) Completion period: Work should be completed within 30 days from date of dispatch of work order. Free services to be provided as & when required within a year.
- 6) Supervision of work: The work shall be carried out under the Supervision of concern S/s In-charges.
- 7) Security Deposit: The contractor should pay security deposit at the rate of 10% of the value within 7 days from the date of receipt of LOI, in the office of the Superintending Engineer EHV O&M Circle Kolhapur in form of cash/ DD of Nationalized Bank or Schedule Bank which will be refunded after completion of work successfully or completion of guarantee period.
- 8) Penalty: The work should be completed within stipulated time after handing over of site, if failed to do so penalty at the rate of 1% of delayed day will be charged subject to 10% maximum of (Order value).
- 9) You shall abide with all Govt. rules, regulations, status for this work including workman compensation act etc.
- 10) Workmanship: The workmanship for this work should be of best quality.

- 11) Guarantee: The contractor will have to provide guarantee certificate for workmanship and material for 1 year from the date of completion of work.
- 12) Agreement Bond: You have to execute the agreement bond on Govt. Stamp Paper of **Rs.500**/- at your cost within 10 days of receipt of order.
- 13) Terms of payments: 100% payment will be arranged on availability of funds by our Circle office, Kolhapur after completion of work and measurement duly certified on bills by concerned Engineer and also submit bill through Bill Tracking System (BTS). Bills will be released for payment after receipt of SAP entry/ creation of PMO by the concern officer & submission of following documents.

1) Bill in triplicate, 2) Guarantee certificate, 3) Joint Measurement Certificate, 4) Security Deposit, 5) Agreement Bond.

- 14) Monitoring of order amount: Contractor has to monitor work order amount. If the work exceeds beyond work order amount, excess amount will not be paid at any cost.
- 15) If the materials are not approved/ received in good condition, the same shall have to be replaced in part or in whole as per case.
- 16) Income Tax & W.C.T. will be deducted from your bills as per rules.
- 17) No extra charges for transportation, T&P, labour, packing, insurance, excise, material etc. will be paid, it will be arranged by you only.
- 18) The enquiry should be completed with all particulars. Wherever, it is mentioned the enquiry must be signed along with seal. Any document of the enquiry not bearing the signature of bidder is liable to be rejected.
- 19) Right to reject any or all quotations is the reserved by the undersigned.
- 20) The rates quoted should be valid for 120 days from the date of opening of quotation.
