- 1) Due Date: The quotations complete in all respects, dully sealed & super scribed should be submitted to this office on or before **dt.12.06.2025** up to **18:00 Hrs.**
- 2) Documents required: PAN/ TAN registration certificate, Valid GST registration certificate, Proof of firm being registered as shop establishment/firm/ Company as applicable & Proforma Annexure-G.
- 3) Quality: Original, Good & genuine parts only utilized for above work. Contract will be terminated without prior notice at any stage, if faulty/duplicate spare found utilized.
- 4) Scope of work: The work involves Repairs of Company's vehicle No. MH-50/5367 (TATA 709 Truck), under EHV O&M Division, Ratnagiri as per **Annexure-W**. The agency should have experienced & qualified staff to carry out the replacement work.
- 5) Completion period: Work should be completed within 15 days from date of dispatch of work order.
- 6) Supervision of work: The work shall be carried out under the Supervision of concern In-charges.
- 7) Security Deposit: The contractor should pay security deposit at the rate of 10% of the value within 7 days from the date of receipt of LOI, in the office of the Superintending Engineer EHV O&M Circle Kolhapur in form of cash/ DD of Nationalized Bank or Schedule Bank which will be refunded after completion of work successfully or completion of guarantee period.
- 8) Penalty: The work should be completed within stipulated time after handing over of site, if failed to do so penalty at the rate of 1% of delayed day will be charged subject to 10% maximum of (Order value).
- 9) You shall abide with all Govt. rules, regulations, status for this work including workman compensation act etc.
- 10) Workmanship: The workmanship for this work should be of best quality.

- 11) Guarantee: The contractor will have to provide guarantee certificate for workmanship and material for 1 year from the date of completion of work.
- 12) Agreement Bond: You have to execute the agreement bond on Govt. Stamp Paper of **Rs.500/-** at your cost within 10 days of receipt of order.
