E-ENQUIRY

Online bids are invited in two bid system (Item Rate Basis) for SRM E-enquiry in r/o detail survey work of cable route for proposed link line 132 kv NCL to 132kv Ganeshkhind ss along with end bays at both end on or before **Dt. 28.06.2025 upto 23.59 Hrs.** Please quote your lowest rates for the works indicated in schedule 'A' enclosed on following terms & conditions:

TERMS & CONDITIONS :

- Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <https://srmetender.mahatransco.in> (Rfx no- 7000036726). The site should be visited before quoting the rates.
- VALIDITY OF ENQUIRY:** - The offer shall be valid for acceptance for a minimum period of 120 days from the date of submission of the offer. During this period no bidder shall be allowed to withdraw his offer. Such withdrawal during the said period shall result in the forfeiting of EMD.
- Work completion period :** The work shall be completed within **30 Days from the date of handing over of site** otherwise penalty @ ½ % of the order value maximum limited to 10% of the order value shall be recovered from the claims of the contractor.
- Value of work : -**
The total value of estimate is Rs.1,72,314/- (Rs. One lakh Seventy Two Thousand Three Hundred Fourteen Only (Including GST)).
- Security Deposit:-** The successful Bidder shall have to pay **Security Deposit of 10%** of the contract/work order value. SD is to be deposited in the form of bank guarantee or FDR of any Nationalized/scheduled Bank in the favour of "MSETCL" valid for one year or online payment NEFT/RTGS within 07 days from the date of issue of LOI or If you fail to do so, it will be deducted from RA bill along with interest as per SBI BPLR for concerned period. No interest will be allowed on this S.D. On the breach of contract during contract period, S.D. will be forfeited without assigning any reason. The amount will be refunded in the normal course, after one month of work completion subject to deduction, if any. Also,

you will have to apply for refund of SD within 6 months after completion of work. If you fail to apply within stipulated period, the action as per CO's rules will be taken.

6. No T & P & Labour will be provided by the Company.

7. Income tax will be recovered from your bill as per rule.

8. Scope of work:-

Detail survey work of cable route for proposed link line 132 kv NCL to 132kv Ganeshkhind ss along with end bays at both end as per the details of items of work under BOQ sheet and as directed by the AddEE S&I sdn Pune/ Engineer - in –charge.

9. Document Submission –

- a) Proof of GST Registration
- b) Proof of factory license or Registration of Firm under Bombay shop & Establishment Act or Copy of SSI Certificate (if applicable).
- c) Experience Certificate:- The contractor should have the experience of similar work in the EHV transmission line survey during last five years. The experience certificate should be uploaded with work order copy.
- d) Income Tax Returns of last financial years i.e. 2023-24 with PAN card copy
- e) undertaking as per 'Annexure-G' format declaring that their Firm is not Debarred / Blacklisted by any Government / Semi Government / Other Power Utilities / MSETCL, anywhere.
- f) Proof of Tender fee and EMD paid. Tender fee and EMD is to be paid by online mode only.

NOTE:- 1) The Bidder has to pay EMD and tender fees in following cases.

- i) If the Micro/Small enterprise Registration Certificate does not indicate the relevant classification code covering material/ service required against the tender floated.
- ii) If the investment in Plant and machinery or Equipment exceeds the threshold limit indicated in the MSMED Act, 2006.
- iii) In case of Works contract, if the Micro and small Enterprise submits that the enterprise shall supply all the materials of intended Works contract, manufactured from its own limit, then it shall be eligible for exemption of payment of EMD & Tender Fees to MSETCL. However, an undertaking duly notarized from micro and Small Enterprise to this effect is to be submitted along with bid.
- iv) The Works contractor except as stated above and Traders are excluded from the benefits of EMD and Tender fees, hence shall be required to pay EMD or tender fees while participating for tender process at MSETCL.
- v) The registration certificate as submitted by Micro and Small enterprise should be valid on the date of submission of Bid and the validity of the same should be certified by the Chartered Accountant in practice.
- vi) In case, the micro and small enterprise (who have been exempted from payment of EMD/ Tender Fees) does not accept the tender being L1, then such micro and small enterprise shall be debarred from the bidding process for all tenders at MSETCL for next 2 years from the date of non – acceptance of L1 bid and this is to be clearly mentioned in all tenders.

10. If any damages occur to the MSETCL property during execution of work you will have to make them good at your own cost.
11. **Agreement:** The successful Bidder should execute the Agreement between MSETCL and the contractor within 07 (Seven) days. The agreement bond of Rs.700/- should borne by the Bidder. If fail to submit the bond of Rs.500/-, the same amount shall be recovered from bidders bill against purchase of agreement bond.
12. **EMD:-** You will have to pay EMD of amount Rs. 5000/- online during SRM processes. The EMD should be paid by On-Line Only. No interest shall be allowed on the EMD. The EMD will be returned as soon as the tender is finalized or canceled. EMD will be returned through ONLINE process, hence it is mandatory to update payment detail of tenderer's registered account.
13. **Additional Instructions for Price Bid Submission:** The MSETCL tender is invited on an Item Rate Basis. Bidders are requested to submit their offers item wise for Supply work as per following instructions below:
- a) Download the BOQ Excel File: - Download the BOQ (Bill of Quantities) Excel file(s) for all parts (viz. Supply & Erection). - Important: Price bids must be submitted in the Excel file(s) attached in the RFX. DO NOT create a new file. Any mistake (intentionally or unintentionally) in submitting the price bid may lead to disqualification.
 - b) Review the BOQ: - Carefully review the BOQ. Each item will be listed with a detailed description, quantity, and unit of measurement.
 - c) Filling the BOQ Excel Sheet: - Fill in the Ex-Work Price (including Labour Cess) column for each item. - Ensure that your quoted pricing are including LC & excludes all Taxes as per BOQ, as the contract will be evaluated and awarded based on the quoted price exclusive of taxes .
 - d) BOQ Excel Sheet Guidelines: - Only fill in the cells designated as editable. The rest of the cells are locked and must not be modified. - Enter the required data in the editable cells only, ensuring that all items are accounted for, and prices are entered for each item. - Important: None of the rate fields should be left blank or set to zero. If the rate for any item is left blank or set to zero, the rate for that item will be considered as zero to MSETCL and the bidder must still supply and execute that item.
 - e) Uploading the BOQ Excel File: - After filling in all the required data, save the Excel sheet without altering any locked cells or creating new files. - Upload the completed BOQ Excel file in the Price Bid Section ONLY
 - f) Compliance: - Any manipulation or non-compliance with these guidelines may lead to the disqualification of the bid. Ensure that the instructions are followed meticulously to avoid disqualification.
 - g) Final Check: - Before submitting, double-check the filled Excel sheet to ensure all prices are entered, and no mandatory fields are left blank or set to zero. - Verify that no modifications have been made to locked cells and that the file format remains unchanged.
 - h) Submission: - Submit the filled Excel sheet in the designated section (Price Bid) of the SRM System as instructed. - The Price Bid quoted in the SRM system should match the price bid uploaded in the Excel format. For bid evaluation and award purposes, the price quoted in the SRM RFX will be considered. - In case of a discrepancy between the price quoted in the SRM RFX and the uploaded

Excel file, the bidder must submit an Excel file of the price bid matching the quoted price in the SRM RFX within 03 (Three days) from the date of price bid opening. Non-compliance may lead to rejection of the bid and further processing as per MSETCL policy. - Convert the completed Excel file into a PDF document. Ensure that the prices in the PDF match those in the Excel file. Submit this PDF, duly stamped, along with the Excel file in price bid section only. This PDF shall be treated as a price break-up.

i) Instructions to refrain from quoting Imbalanced Rates: - Balanced pricing Requirement: Bidders must ensure that their quoted prices for Supply & erection works are balanced and reflect realistic market rates. Imbalanced pricing, where one part of the work is significantly under/over quoted compared to the others, is not acceptable. - No Cross-Subsidization: Bidders should not artificially lower the price of one component while inflating the price of another component. Each part of the bid must have transparent and justifiable pricing based on its own basis. - Proportionality Check: The prices for Supply & erection works should be in reasonable proportion to each other, reflecting the actual costs involved in each portion. MSETCL reserves the right to assess and conduct a detailed analysis of the submitted bids to verify the consistency and appropriateness of the quoted rates and MSETCL will have discretion to reject bids that show significant discrepancies between Page 12 of 13 these components Note: MSETCL reserves the right to check the price bid file(s) after the opening of the price bids and may reject any bid that has not followed the above instructions. MSETCL also reserves the right to request clarification on pricing details. Adherence to these guidelines is crucial for the successful bid submission.

14. Prohibiting participation of Bidders Debarred / Blacklisted by Government / Semi Government / Other Power Utilities: Bidders will have to submit an undertaking as per 'Annexure-G' format, declaring that their Firm is not Debarred / Blacklisted by any Government / Semi Government / Other Power Utilities / MSETCL, anywhere. If it is revealed that the participating Bidder is Debarred / Blacklisted by any Government / Semi-Government / Other Power Utilities / MSETCL, anywhere, the Offer of such Bidder shall be liable for rejection at any stage of the Tendering process. Further, if it is revealed that the successful Bidder is Debarred / Blacklisted by Government / Semi Government/Other Power Utilities / MSETCL, anywhere, then Order of such Bidder shall be liable for termination at any stage of Order execution process and the concern Bidder shall be solely responsible for the consequences arising there from.

15. TERMINATION OF CONTRACT:- The undersigned reserves the right to accept or reject the Enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days without assigning any reasons, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.
