 - Valid vehicle Insurance.
 - Fitness certificate / Passing certificate
 - PUC.
 - Pan Card
 - ITR acknowledgement for last two years
 - Certificate of Registration under GST & last paid GST challan (if applicable).
 - Registration under Bombay Shops and Establishments Act, 1948, if applicable.
 - EMD is to be paid as per circular no. 10812 dt-10.10.2018. The registration certificate as submitted by micro & small enterprise should be valid on the date of submission of bid & the validity of the same should be certified by the Chartered Accountant in practice.
 - The vehicle should be of model not earlier than April 2020.
 - The vehicle provided should be a CNG/Diesel/Petrol vehicle only.
