The sealed & subscribed quotations are invited from MSETCL's authorised vendors for work of supply & installation of Licence free Walkie – Talkie along with technical catalogue for 3 Kms. range as per the Schedule 'A' attached herewith subject to following terms & conditions

TERMS AND CONDITIONS :

- 1) The quotations should reach to this office on or before **02.07.2025 upto 16.00 Hrs.** This office shall not accept any responsibility for late receipt of quotations due to postal delay.
- 2) The bidder should be manufacturer or authorized dealer of Walkie - Talkie who has specifically executed "Supply of Walkie - Talkie" and its installation work, successfully in MSETCL / PGCIL or any Govt./Semi-Govt. Organization.
- 3) The contractor has to furnish GST, PAN No. in the offer.
- 4) The bidder should submit catalogue along with offer
- 5) **The rates quoted by the bidder, shall be considered as inclusive of GST & all other duties, taxes other levies LW Cess, IT etc. which are payable by the contractor as per statutory regulations.**
- 6) Income tax shall be deducted from the bills at prevailing rates, as per Income Tax Act 1961.
- 7) Bids shall remain valid for 120 days after the date of bid opening prescribed by the employer.
- 8) **Security Deposit :** Within Fifteen (15) days of the receipt of notification of award i.e. the letter of intent from the Employer, the successful bidder shall furnish the security deposit amounting to 10% of the contract value by RTGS/Cash.
- 9) **Period :** The time period for completion of the item under Schedule 'A' under this contract will be **30 days**. The period shall be entitled from date of intimation from MSETCL.
- 10) If the work is not completed within stipulated period, the liquidated damages shall be levied at ½% (half percent) of the total contract price per week of delay subject to maximum of 10% (Ten percent) of the contract price for the entire scope of work.
- 11) **Warrantee / Guarantee :** 1 Year from date of installation.
- 12) **Services :** The agency should provide 1 Year service for the Walkie Talkie setup.

- 13) **Payment will be made by EHV Projects Division, Kolhapur after completion of 100% work by the contractor for all approved works executed as fixed by the Engineer after scrutiny of bills at concerned Sub-Division Office.**
- 14) The contractor has to execute the agreement on stamp paper as per Govt. rule, before commencement of work.
- 15) All T & P, Labour, Crane etc. shall be arranged by the contractor at his own cost if required.
- 16) The contractor shall make his own arrangements for the engagement of all labour local or otherwise and shall make his own arrangement for their accommodation & transportation. Permission will not be granted to stay at site.
- 17) The contractor shall not sub-let the works awarded on him under this contract.
- 18) Quotation incomplete in any respect shall be rejected.
- 19) Executive Engineer reserves the right to reject any or all the quotations without assigning any reason therefore.
- 20) Quotation received late or with incomplete details against above clauses will not be considered.
- 21) Labour welfare cess/ GST/other statutory payment etc. considered in contract value will be deducted at appropriate rate prevailing during tenure of contract.
- 22) **Submission of offer:** The vendor should submit Annexure 'A' signed & sealed offer before due date alongwith necessary documents at office address: **Office of Executive Engineer, EHV Projects Division, Kolhapur, Vidyut Bhavan, Admm. Building, 2nd Floor, Tarabai Park, Kolhapur. 416003.**


