## **Re-publication of Notification for Inviting Budgetary Offer**

**Sub:** Submission of budgetary offer for design, supply, foundation and erection of 220kV MC Monopole (4 Ckts & 6 Ckts) tower for work of construction of LILO on 220kV Eklahare-Navsari line to proposed 220/132/33kV Mhasrul GIS Sub-station (upgradation of 132kV Mhasrul Sub-station) in existing 132kV line corridor under EHV Projects Circle, MSETCL, Nashik.

With reference to above subject, In view of upcoming Kumbhmela event in 2027, the EHV infrastructure shall require to be sturdy enough to cater the future load growth as well as achieving ample redundancy and uninterrupted availability of power supply in the Nashik area to cater the load of Kumbhmela 2027. Accordingly, existing 132kV Mhasrul substation is proposed to upgrade to 220kV level in existing switchyard. Also it is decided that, the associated 220kV & 132kV lines are required to be established in existing 132kV line corridor (27 mtrs belt).

The tentative scope of work is as below and it is requested to provide budgetary offer considering the terms and conditions mention below;

  - d) Clearances should be as per CEA guidelines.
