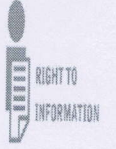

Sealed percentage rate quotations are invited from experienced Contractors in Similar Works as per schedule enclosed. The quotations should be submitted to the office of Executive (Civil) EHV CCCM Division Chatrapati Sambhajnagar Building, First Floor, wing no.102, Chatrapati Sambhajnagar on or **before dated 1.08.2025 Time 13.00 Hrs**


TERMS AND CONDITIONS:

- 1) The work shall be carried out as per schedule attached herewith and instructions of the Engineer in-Charge and to the satisfaction of the undersigned.
- 2) The quantities mentioned in the attached schedule are approximate and likely to vary However, payment will be made as per the work actually executed and measured.
- 3) The rates are inclusive of cost of all material, labour, plant, equipment, temporary works, tools, setting out, supervision, transportation, royalties, octroi and any local state or central taxes or levies payable on all transactions, insurance, labour cess, and everything necessary for due completion and proper performance of all works under the contract, all taxes except GST.
- 4) The work should be completed within **(18) MONTHS** from the date handing over the site, failing which the contractor shall be liable to pay as compensation an amount equal to one percent or such similar amount as

the competent authority may decide of the W.O cost for every day the work remain unfinished after due date of completion subject to the maximum 10% of the cost of the order.

- 5) The work which is of bad workmanship quality will not be measured and paid.
- 6) The contractor will have to make good the damages if any made by him during the execution of work at his own cost.
- 7) The material should be got approved prior to fixing from the Engineer-in-charge.
- 8) Income Tax as per the prevailing income Tax rule and subsequent amendment thereof will be recovered at source of your bill on total value of work done for which the certificate will be issued if desired.
- 9) Contractor will be held responsible for accident occurred during the course of the work and will have to pay the compensation as per the act 1923 and subsequent amendment thereof.
- 10) Contractor should submit his bill in triplicate through Addl. Executive Engineer (Civil) EHV CCCM Sub-Division-II Chatrapati Sambhajinagar. Payment will be made within 60 days period from the date of receipts of bill to this office.
- 11) The terms and conditions in the M.S.E.T. Co. Ltd. Booklet 'Tender and contract work' will stand applicable for this work and final terms & conditions will be mentioned in Work Order.
- 12) You will have to deposit Rs.33,500/- (5% of Quotation value) as security deposit in cash/DD/FDR of any nationalized Bank within 3 days from the date of receipt or receipt of work order, failing which EMD will stand forfeited.
- 13) The contractor's offer will be considered as inclusive of all taxes and charges and it will be the contractor's responsibility to pay the taxes to Government and same will not be reimbursed to the contractor.
- 14) Contractor shall submit duly filled quotation in sealed envelope with name of the work, EMD transaction no, name of agency written on envelope, address of vendor and stamp. The Contractor shall submit GST Certificate if applicable, PAN No etc.
- 15) Contractor shall quote its offer in words and figures at place given in memorandum of quotation attached herewith. Scratches and over written rates shall not be considered if not initialed.
- 16) The contractor has to pay earnest money to Rs.6,700/- in cash/RTGS/NEFT/In form of DD/FDR of any Nationalized Bank in favor of Executive Engineer (C) EHV CCCM DIV. MSETC Ltd. Chatrapati Sambhajinagar. If the EMD of required amount is not found in the envelop the quotation will be rejected.
- 17) The undersigned reserves the right to reject any or all quotations without assigning any reason what so ever.
- 18) GST will be recovered from your bill as per GST norms.

- 19) Special condition: The payment shall be effected as per fund availability. Due to shortage of fund there are chances of delay in payments for which the agency will have to bear with the Dept. No. any of claim on this account will be entertained.
- 20) The estimated cost of the work is **Rs.6,68,820.00 only**. (Inclusive of all Taxes)
- 21) The Contractor has to submit of Valid Shop Act Registration Certificate, GST Certificate, PAN Card, EMD Paid receipt (M.R. Copy) as mandatory documents at the time of submission of Quotation.
- 22) As per rules of M.S.E.T.C.L., the Contractor will have to enter into an agreement with the Executive (Civil) EHV CCCM Division Chatrapati Sambhajanagar Building, First Floor, wing no.102, Chatrapati Sambhajanagar for the above works, as early as possible and until such agreement is executed with the Company, the M. 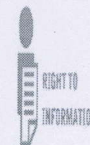
