- 2) The GST registration Certificate if registered, PAN xerox copy must be enclosed with quotation.
- 3) If registered under SSI, the Photo copy of the registration should be attached with the quotation.
- 4) Material shall be warranted for minimum 1 year.
- 5) Material shall be provided as per Schedule 'A'
- 6) Material should be delivered within 30 days from the date of the issue of order at MSETCL, The Executive Engineer, 400KV R. S. Division, Talandage. Three days will be reckoned for transit. The condition for delivery should be mentioned specifically otherwise, it will be presumed that you will supply the material within stipulated time.
- 7) The rates quoted shall be on firm quotation basis.
- 8) The envelope should be super scribed as "QUOTATION FOR SUPPLY OF 2 NOS OF ROUTERS TO REPLACE EXISTING CISCO MAKE ROUTERS AT 400KV R. S. DIVISION TALANDAGE".
- 9) **Equipment should meet safety requirements as per IEC standards.**
- 10) The documentation containing details of router of manufacturer to be supplied should be enclosed along with quotation such as make, type/model, specifications etc.
