## NOTICE INVITING EXPRESSION OF INTEREST FOR TRANSFORMER AUGMENTATOIN WORKS UPTO 132 kV LEVEL UNDER NEW VENDOR DEVELOPMENT POLICY

Maharashtra State Electricity Transmission Co. Ltd is inviting **Expression of Interest** for execution of Transformer Augmentation works upto 132 kV level at various EHV Sub-Stations on trial basis orders from the vendors fulfilling following qualification criteria.

- 1) Vendors who have executed works on Turnkey basis in MSEDCL for at least 05 (Five) numbers of 33/11 kV or 22/11 kV Sub-stations, in last 03 (Three) years, having at least one Transformer of 10 MVA capacity at each sub-station and having Minimum Annual Average Turnover (MAAT) in last three years of Rs 50 Cr.
- 2) Vendors who have executed at least 02 (Two) numbers of Sub-Station on Turnkey basis for 100 kV and above level at Consumer / Generators / TSS / Irrigation etc premises, during last 03 (Three) years, under ORC Schemes under supervision of MSETCL and having Minimum Annual Average Turnover (MAAT) in last three years of Rs 25 Cr.

The Expression of Interest in the prescribed format along with relevant documents shall be submitted to MSETCL on or before 31<sup>st</sup> July 2025 @ 14.00 Hrs.

## **Note**:

- a) The Expression of Interest shall be submitted on email IDs with subject clearly mentioned as "Application for Expression of Interest from M/s....." for Transformer Augmentation Works upto 132 kV level on Trial basis.

- c) The undertaking on the letter head of vendor stating that "We M/s...... is fulfilling the mentioned Criteria for submission of Expression of Interest for Transformer Augmentation Works upto 132 kV level on Trial basis and have submitted all required documents along with the mail.
- d) The Application for Expression of Interest shall be submitted on or before 31<sup>st</sup> July 2025 @ 14.00 Hrs

For Vendors who have executed works on Turnkey basis in MSEDCL for at least 05 (Five) numbers of 33/11 kV or 22/11 kV Sub-stations, in last 03 (Three) years, having at least one Transformer of 10 MVA capacity at each sub-station and having Minimum Annual Average Turnover (MAAT) in last three years of Rs 50 Cr.

- Experience certificates for execution of works on Turnkey basis in MSEDCL for at least 05 (Five) numbers of 33/11 kV or 22/11 kV Sub-stations, in last 03 (Three) years, having

- at least one Transformer of 10 MVA capacity at each sub-station, duly certified by the officer not below the rank of Executive Engineer, MSEDCL.
- The performance certificates for at least one year for the above works duly certified by the officer not below the rank of Executive Engineer, MSEDCL.
- Copies of the work orders for above mentioned works.
- Certificate from Chartered Accountant with seal and UDIN for Minimum Annual Average Turnover (MAAT) of Rs 50.00 Cr. in the last three years i.e. 36 months.
- Name of MSETCL Zones in which bidder is interested for execution of the works. (Viz. Pune, Nashik, Vashi, Nagpur, Nashik, Karad, Chatrapati Sambhajinagar Zone)

Vendors who have executed at least 02 (Two) numbers of Sub-Station on Turnkey basis for 100 kV and above level at Consumer / Generators / TSS / Irrigation etc premises, during last 03 (Three) years, under ORC Schemes under supervision of MSETCL and having Minimum Annual Average Turnover (MAAT) in last three years of Rs 25 Cr.

- Experience certificates for execution of work of least 02 (Two) numbers of Sub-Station on Turnkey basis for 100 kV and above level at Consumer / Generators / TSS / Irrigation etc premises, during last 03 (Three) years, under ORC Schemes under supervision of MSETCL and having Minimum Annual Average Turnover (MAAT) in last three years of Rs 25 Cr.
- The performance certificates for at least one year for the above works duly certified by the officer not below the rank of Executive Engineer, MSETCL.
- Copies of the work orders for above mentioned works.
- Certificate from Chartered Accountant with seal and UDIN for Minimum Annual Average Turnover (MAAT) of Rs 25.00 Cr. in the last three years i.e. 36 months.
- Name of MSETCL Zones in which bidder is interested for execution of the works. (Viz. Pune, Nashik, Vashi, Nagpur, Nashik, Karad, Chatrapati Sambhajinagar Zone)
- f) The Expression of Interest are called by MSETCL as a part of vendor development measures. However, MSETCL does not binds itself to allot the works on the basis of the application from vendors. The procedure for allocation of the work will be at the sole discretion of MSETCL.
