- 2) Tender Fees **Rs. 500 /-** (excluding GST) non-refundable should be paid on-line only. **Payment in cash/DD will not be accepted.** Bidder can pay through Credit card/Debit Card/ Net Banking. The payment confirmation will be done by the Corporate Office.
- 3) EMD amount of **Rs. 59,183.94 /- @ 1%** of estimated cost will have to be paid by the bidder through online mode only. **OR** The bidder will have to furnish Bank Guarantee of any nationalized/ scheduled Bank in prescribed format equivalent to 1% of the estimated cost in lieu of bid security deposit in the name of **Superintending Engineer, EHV O&M Circle, Amravati payable at Amravati** at the time of submission of bid documents with **validity of 8 months from the date of opening of techno-commercial bids.** Bidder should upload the color scanned copy of Bank Guarantee in bids documents and physical hard copy of the same should be submitted to this office within 5 days after sale closing.
- 4) Tender documents can be downloaded only online from above-said website.
- 5) Eligible bidders shall submit their bids well in advance instead of waiting till last date. MSETCL will not be responsible for non-submission of Bid due to any website related problems.
