- 1. **NAME OF THE WORK:-** Work of Day to day Cleaning & sweeping works of 400KV Control Room Building & outside premises of 400KV Control Room Building at 400KV RS Karad.
- 2. **DUE DATE:-** The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either personally or by post on or before **Dtd.11.08.2025 upto 18:00 Hrs** positively.
- 3. **DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :-** Please submit the following documents along with offer :
