Sealed and subscribed percentage rate quotations are invited for the above-mentioned work as per the Schedule 'B' enclosed. The quotations should reach this office on or before 12.08.2025 up to 16.00 hours.

TERMS AND CONDITIONS:

- 1) The time limit allowed for completion of the above work is 15 Days from the date of handing over of site, failing which the contractors shall be liable to pay compensation an amount equal to half of one percent of the total amount of unfinished works per week or part of the week's delay Or Rs. 250/- per day of delay whichever is more, however, subject to maximum penalty limited to 10% of the entire contract amount. (And not the amount of unfinished works)
- 2) The quantities mentioned in the attached schedule "B" are approximate and may vary during the course of execution. Contractor will have no claim for the alteration. However, payment will be effected as per the actual measurements, measured at site as per M.S.E.T.C.L.'s rules.
- 3) Quoted rates should be firm and should include all charges such as duties, all types of taxes, Insurance, labourcess, tolls etc. complete. Nothing extra will be paid on any account over the quoted rates except service tax. Service tax as applicable which is shown in the Schedule "B" or as per prevailing rate will be paid separately.
- 4) Contractor will have to make good damages, if any, made by him to the M.S.E.T.C.L.'s property during the execution of entire work at his own cost, otherwise the same will be got done by the M.S.E.T.C.L. at contractor's risk and cost.
- 5) Contractor will be responsible for any type of accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing "Workman's Compensation Act"
- 6) Contractor will have to pay Earnest Money Deposit of Rs. 4,368.00/- through cash / DD along with MR.

- 7) Contractor will have to pay Security deposit equal to 5 percent of work order value in this office within seven days from the receipt of work order in the form of BG or Demand Draft of any schedule bank drawn in favour of "Superintending Engineer (Civil), EHV CCCM Circle, M.S.E.T.C.L., Airoli" payable at Navi Mumbai.
- 8) Payment will be made by division office in the form of RA Bill, within a reasonable period after receipt of the same duly audited from the Superintending Engineer (Civil), EHV CCCM Circle, Airoli on submission of bill in triplicate by the contractor after satisfactory completion of the entire work.
- 9) Whenever there is paucity of funds, the priority of payments of bills of various agencies will be decided by the undersigned and all the rights in this regards are reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest / compensation due to delay in their payments of bills on account of paucity of funds.
- 10) Income tax, Insurance, Labour cess, GST as applicable will be recovered from the bill on the total value of the work done as per the prevailing rates for which recessary certificate will be issued from this office.
- 11) You will have to attach all the following documents to the offer while submitting the response online. In case of failure to do so, the offer shall liable to be rejected. (a) Valid registration under Shop & Establishment Act (b) GST certificate/or declaration certificate (c) EPF Registration Certificate or declaration certificate, (d) PAN Card (e) Two years' experience extra. The experience certificate issued by an officer not below the rank of Executive Engineer or depending upon the case is to be submitted. Besides this, contract shall also be governed by the M.S.E.T.C.L.'s Standard Terms & Conditions of Contract.
- 12) The bidders should be a registered vendor of M.S.E.T.C.L. Those who are not a registered vendor and wish to participate in the bid shall have to obtain vendor registration from M.S.E.T.C.L. by submitting necessary application & documents to this office well in advance prior to submitting their offer.
- 13) The offer quoted for this quotation shall be valid for **120 days** period from the due date / extended date, if any, of submission of the quotation.
- 14) Right to reject any or all quotations without assigning any reason is reserved by the undersigned.
