- 1. The Delivery of material should be done within '30 Days' to the person in charge of Hot Line & PID Unit, Ogalewadi.
- 2. Quantities mentioned in Schedule 'A' are fixed. The material must be supplied to Hot Line & PID Unit, Ogalewadi, as per the Specifications mentioned in Schedule 'A', and if not material will not be accepted.

#### 3. The following documents should be submitted along with the quotation

- 1. Registration copy under the Shop Act / NOC from the Gram panchayat / Registration under Udyam Aadhar 2. Valid copy of GST registration 3. Pan Card. 4. Income Tax Return copy for the Assessment year 2024-25.
- 4. Quotations should be duly filled in all respects and signed, failing which they will be liable for rejection.
- 5. In case of any dispute, the decision of the undersigned shall be final and binding on the contractor.
- 6. The Work order amount will be limited to Rs. 57,112 (Including all Taxes). Taxes should be quoted distinctly, if any. If not, it will be assumed that rates are inclusive of all Taxes & all applicable charges.
- 7. All the bills should be submitted to this office along with MOM after satisfactory completion of supply, for arranging payment. Payment shall be made as per the measurement as per MSETCL's rules
- 8. **PENALTY:** If you fail to carry out the work within the stipulated period, a **penalty of ½ % per delayed day** or part thereof will be levied on you, subject to a maximum of 10% of the total value of this order. However, due consideration will be given in lieu of a penalty for the

reasons absolutely beyond your control, for which documentary evidence will have to be produced by you.

- 10. The work should be carried out as per the enclosed Schedule 'A'.
- 11. The right to reject any or all quotations without assigning any reasons thereof is reserved by the undersigned.
