The conditions are :

- 1) Monopole should be of Regular type and the spans between two poles ranges between 63-370 mtrs.
- 2) Soil type along the route is DFR & HR.
- 3) 0.4 ACSR Zebra conductor for 220kV Work and 0.2 ACSR Panther Conductor is to be used, thus Monopole should be designed considering this conductor stringing.
- 4) Pune metro, Proposed National Highway crossing is there.
- 5) Work is to be so planned & executed that it should be completed in minimum outage plan.
