With reference to above subject, you are requested to quote lowest possible rates for Servicing, Overhauling of Valve Cooling motors & its alignment with pumps and Servicing, Overhauling and Testing of LVAC breakers 2000 C and 3200 D type along with spares for Pole-1 & 2 at HVDC Terminal Station, Padghe during Annual Outage – 2025 as per specification in Schedule – A with following terms and conditions.

TERMS AND CONDITIONS:

1. The EMD and Tender fees is to be paid online on the account of '*The Company*' through website <https://srmetender.mahatransco.in>. **Due Date-. 02.09.2025 upto 10:00 Hrs.**
2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- The bidder should **submit at least one similar nature of work order copy equal to minimum 50%. The order should be after 01st April 2018 along with its experience certificate for similar nature of work as per schedule-A.**
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer.

Commercial Bid.

- PAN Card of the firm/proprietor as the case may be. Income Tax return for last one year.
- Certificate of Registration for GST with latest paid Challan.
- The bidder should have a valid Electrical Contractor's License issued by the Government of Maharashtra for work of erection/commissioning of EHV equipment.
- Shop Act License.
- Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- Net Worth of last one year duly certified by Chartered Accountant should not be less than 25% of estimated cost.

3. Scope of Work:

- Servicing, Overhauling of Valve Cooling motors & its alignment with pumps and Servicing, Overhauling and Testing of LVAC breakers 2000 C and 3200 D type along with spares for Pole-1 & 2 at HVDC Terminal Station, Padghe during Annual Outage – 2025.
 - '**The Company**' will hand over all the Breakers in normal working/Healthy condition and it will be the sole Responsibility of vendor to hand over all the Breakers in healthy condition after maintenance and testing. Any component failure during the process of maintenance is to be supplied by the vendor free of cost.
 - Work completion certificate is to be submitted by the Vendor after testing and maintenance of Breakers.
 - Also vendor should give warranty of 12 months from the date of Maintenance.
 - For execution of work, all T&Ps should be brought by agency personnel during work such as CRC, Polish paper, blower, Jelly, Timing Kit etc & extra material and T&P will not be given by '**The Company**'.
 - The company will hand over all the motors and pumps to the vendor in normal working/healthy condition and it will be the sole responsibility of the vendor to hand over all the motors and pumps in Healthy/ Working condition after maintenance and Testing. Any component failure during the process of maintenance and alignment is to be replaced by the vendor free of cost.
 - Work completion certificate needs to be submitted with the bill.
 - Vendor must give warranty for 12 months from the date of maintenance and alignment. Vendor must bring all T&P including Polish paper, CRC, Jelly etc. required for maintenance and alignment of valve cooling pumps and motors. No material will be provided by the 'Company'.
 - Precision of Alignment should be (Toleration :<5tau)
4. The Contractor rates should be in percentage (%) based on estimate cost.
 5. Rates should be valid for 120 days after commercial opening of the enquiry.
 6. Rfx fee is Rs.118/- including taxes (Is non refundable).
 7. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
 8. Income Tax will be deducted from contractor's bill, as per Govt. Rules
 9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
 10. **Guarantee:** The Contractor will have to give a guarantee of work done by him for the period of 12 months from the date of work done at site.
 11. **Agreement:** The contractor will have to enter into an agreement at his cost with "The Company" in the prescribed pro forma - on Non Judicial bond paper / franking paper / Paper where payment is made to concerned authority of Govt. by e-transfer for registration - within 10 (Ten) working days from the receipt of the Letter intimating from the office of The Superintending Engineer, HVDC R S O & M Circle, MSETCL, Padgha.
 12. You have to pay the security deposit of amount equal to 5%(Five) of the order value within 07 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (O&M) Circle, Padghe, Tal. Bhiwandi, Dist. Thane, Demand Draft or equivalent Govt. Securities or Fixed Deposit Receipt or RTGS.
