

TERMS AND CONDITIONS:

- 1) The work should be carried out as per schedule B attached and instructions of the Engineer incharge and to the satisfaction of the undersigned.
- 2) The quantities mentioned in the attached schedule are approximate and likely to vary. However, payment will be made as per the work actually executed and measured. The rates shown in enclosed schedule B are inclusive of GST.
- 3) The work should be completed within (06) Six Months from the work order, failing which the Contractor shall be liable to pay as compensation an amount equal to one percent or such similar amount as the competent authority may decide of the W.O. cost for every day the work remain unfinished after due date of completion subject to the maximum 10% of the cost of the order.
- 4) Contractor shall have to arrange concern books related to the work at his own cost without involving any financial implications to MSETCL.
