- 1) DUE DATE: The quotations in two bid system (Single Envelope shall be submitted containing\_one quotation for technical bid with all supporting documents & another for Commercial bid with price break up) complete in all respects, duly sealed & super scribed should be submitted to this office on or before 31/08/2025 up to 17:00 Hrs. positively.
- 2) SCOPE OF WORK: as per schedule 'A', material should be strictly as per specification
- 3) **QUOTED RATES: -** The quoted rates should include GST Taxes, Delivery Charges and installation and commissioning & other Charges. If nothing mentioned it will be considered inclusive of all taxes & charges.
- 4) **DELIVERY PERIOD:** 15 days from the date of receipt of order from EHV Projects cum O&M Zone Office, Nashik.
- 5) AGREEMENT: -

Bidder should have to execute the agreement at zonal level as per the provision of "Mumbai Mudrank Adhiniyam 1958, Clause No. 34" with requisite stamp duty. The necessary stamp duty & bond paper for the agreement shall be borne by the Contractor.

- 6) **GUARANTY/WARRANTY PERIOD:** The supplied product should be Guaranty/Warranty period **01 year** from date of installation and commission by bidder.
- 7) **SECURITY DEPOSIT:** The successful bidder will have to submit security deposit @ 10% of order value in the form of unconditional FDR/D.D./B.G. of any Nationalized/ scheduled Bank in the name of the CHIEF ENGINEER CAFS NASHIK ZONE payable at Nashik to this office

within 07 days from the receipt of LOI/Supply Order. The same will be refunded to you  $\underline{01}$   $\underline{\text{year}}$  after expiry Guaranty/Warranty period.

In the event of unsatisfactory performance of the contract or non-compliance to T&C, Scope of Works then SD will be forfeited. No interest will be paid on this submitted security deposit.

8) **PAYMENT:** - On completion of the order successfully, the bill in triplicate should be submitted to EHV PC O&M Zone Nashik. After scrutinizing of bills the payment will be made within a reasonable time through EHV O&M Circle, Nashik.

## 9) DOCUMENT REQUIRED: -

(a) Compulsory Primary Documents in 1st Envelop: (Technical Bid)

- d. Pan Card.
- e. Photocopy of GST registration certificate (if applicable)
- f. Order copies of supply of experience of such type of material under any Power Utility/Government Dept./PSU/Bank.
- g. OEM authorization Certificate

# (b) Documents in 2nd Envelop:(Price Bid)

Price bid envelop contain, the rates of product as per **Annexure "A"** i.e. Ex-work rate of product **Plus** applicable GST.

NOTE: - Envelop No.2 (Price Bid- envelop) will be opened after qualifying in (Technical Bid) Envelop No.1

- 10) The undersigned have the reserve right for relaxation of any condition mentioned above.
- 11) The undersigned reserves the right to reject any or all quotations or cancel the requirement at his discretion without assigning reasons thereof.
- 12) **TIME IS THE ESSENCE OF CONTRACT:** The time stipulated in the contract for the completion of the work shall be deemed to be the Essence of the Contract. The Contractor shall so organize his resources and perform his work as to complete the work within stipulated time period.

## 13) Terms & Conditions of Contract

- b) Bidder should quote the firm price and price variation will not be applicable.

- 14) **PENALTY:** The Supply should be completed within time period and completed as per directives of operating officer/Engineer In charge, failing to which the penalty will be charged at the rate of @ 0.50% (half percent) per week (On delayed portion) or part thereof. The total amount of penalty charged will be subject to maximum of 10% of the ordered value.
- 15) **TERMINATIONS OF CONTRACT:** The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of the breach of contract in any respect or undue delay in execution of works /starting of the works. This order is placed upon documents submitted & facts represented by you. If it is found at any stage that, the documents submitted/facts represented by you in relation to the bid regarding eligibility criteria, rates offer etc. are untrue/fake/invalid & there is suppression of facts, misrepresentations, and any sort of cartelization among the bidders to obtain the order resulting in loss to the MSETCL is at your risk, costs responsibility & subject to legal action.
- 16) **JURISDICTION:** All the disputes arising out of this contract shall have exclusive jurisdiction of court in Nashik
