Terms & Conditions

- a. The Service Provider shall provide the 52 Mbps Internet leased line connectivity at all the time (24X7X365) at MSETCL, Karad Zone office premises, Vijaynagar.
- b. Network Availability (uptime): More than 99.50 % per month.
- c. National Backbone should be available on the same ISP.
- d. Reports for performance, monitoring / usage to be submitted by the ISP on monthly basis or as per requirement of the MSETCL.
- e. Downtime Calculation: Downtime shall be calculated as $(\text{Total Time} - \text{Down Time}) \times 100 / \text{Total Time}$. Deduction in payment will be made for downtime in the quarterly bills raised by the ISP.
- f. The response time for attending the faults will be 1 hour after they are reported to the ISP. The ISP will rectify the faults within 12 hours failing which; the vendor will arrange temporary replacements. The services shall be provided 24 X 7 days in a week.
- g. Downtime penalty in % of quarterly payment:
