Sealed and super scribed uniform rate quotation are invited in the above mentioned work as detailed in " Schedules" attached herewith so as to reach the office of the undersigned at the above mentioned address.

The bidder has submit super scribed envelop in two bid system. The 1st Envelop containing technical bid and 2nd Envelop containing commercial bid. Shall be reached to this office on or before **08/09/2025 up to 15.00 Hrs.**

TERMS AND CONDITIONS

1) Compulsory Primary Documents:(Technical Bid)/ TQR.

- (i) Valid Certificate of Registration of appropriate class for PWD Civil Contractor License from PWD /MES/ Railways/ Jeevan Pradhikaran ETC.OR From Any Govt. / Central Government and registered vendor of MSETCL.
- (ii) GST/ GSTIN Registration Certificate.
- (iii) PAN Card
- (iv) E.P.F. Registration Certificate – issued by competent authority of Govt
- (v) Experience of having successfully completed Civil works.
- (vi) Bidder has to submit undertaking for physical verification of the material on site on his letter head with date.
- (vii) Price bid only where in the firm rate basis should be quoted in attached A & B in commercial bid envelop.

NOTE:- Price Bid will be opened after qualifying in Technical Bid.

- 2) Rates quoted shall be inclusive of dismantling & disposing off all material/debris of staff quarter buildings and Rest House (Type- C, Type- D, Type- E, Type F & Rest House) and disposing off all debris outside the premises of 132 KV substation Igatpuri (Bortembhe) (as mentioned in schedule) Transportation, Loading, Unloading and other incidental charges. Nothing extra on any account will be paid. The highest positive difference amount between Schedule- A & Schedule-B will be considered for the qualification for the work order.
- 3) No material shall be issued by the department.
- 4) All T&P, Labour, Water etc will have to be arranged by the Contractor at their own cost.
- 5) Work shall be done within **15 Days** from receipt of Work order/handing over of site, failing which penalty at the rate of ½ % per week to maximum upto 5% of Schedule "A" amount will be levied and recovered from deposited amount.
- 6) If any damage occurs to the Company's property during execution, contractor will have to make it good at his own cost and risk.
- 7) If any accident occurs to contractor's labours during the execution of work, the Company will not be responsible for the payment of any compensation of them. In such cases, it will be the contractor's responsibility to pay the compensation as per the Workmen compensation act and the rules made there under. Also contractor has to draw the insurance.
- 8) The terms & conditions enumerated in the approved Booklet "TENDER AND CONTRACTOR FOR WORKS" will be applied in this case & will be binding on the contractor entirely.
- 9) Right to reject any or all quotations is reserved by the undersigned.
- 10) The rates quoted will be valid for 120 days from the date of opening of quotation.
- 11) In case of any disputes, the work order for this work shall be final and binding on contractor.
- 12) In case of any disputes, the work order for this work shall be subject to Nashik Court/ Mumbai High Court's jurisdiction only.
- 13) Contractors are requested to inspect the site of work before submitting the quotation. Tax Act 1961, applicable to agency.
- 14) Price variation & price Escalation: - No Price escalations clause is applicable for this work. The work shall be completed within 15 Days from the date of handing over of site.
- 15) Deposition of work amount:-

Contractor has to pay the amount as per difference of scrap receivable amount (Schedule A) – expenses for demolishment (Schedule B) which is non refundable. Further, contractor has to deposit 10% SD separately of above value against this work to this office within 07 days prior to commencement of work or as directed. MSETCL has decided the base value of difference amount to be paid by bidder to MSETCL bids received below this amount will be rejected.

16) Payment of **EMD Rs. 2000 & quotation fee Rs. 500+ 18% GST** to be made by bidder online & having registered vendor of MSETCL.

21) The statutory norms for labour show be followed by the agency


22) GST: - GST will be applicable as per prevailing rules of Govt.
