**TERMS & CONDITIONS:**

1. **NAME OF WORK:** Work of replacement of Earthwire for various 220/132/110KV EHV Lines under LMSDN Satara under EHV O&M Division Karad.
2. **DUE DATE:** - The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either in person/post on or before **Dtd. 10.09.2025 upto 17:00 Hrs** positively.
3. **DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS:** - Please submit the following documents along with offer:
  1. Registration under PAN & GST.
  2. Registration under Bombay Shop & Establishment Act/NOC from local Grampanchayat.
  3. Valid electrical contractor's license.
  4. The bidder should submit experience certificate for the work of replacement of Earthwire for 110KV EHV Lines & above, for 25% of estimated amount (single work order), i.e. Rs. 1,04,710/-; for the work carried out in last Five years in MSETCL; certificate regarding the same from an authority not below the rank of Executive Engineer.
4. **QUOTED RATES:** - The quoted rates should include the cost of all taxes. The taxes will be clearly mentioned, & if the taxes are not clearly mention, then it will be presumed that the rates are inclusive of all taxes.
5. **VALIDITY OF OFFER:** - The offer should be valid for acceptance for a period of **90 days** form the due date of same.
6. **SCOPE OF THE WORK:** -The scope of work is as per mentioned in Schedule 'A'.
7. **AGREEMENT:** -You have to execute Indemnity cum agreement bond on stamp paper of **Rs. 500/-** in prescribed format at your cost.
8. **OPERATING AUTHORITY:** - **Addl. Executive Engineer, Line Maint. S/Dn Satara Incharge** is appointed as operating officer for this order.
9. **COMPLETION PERIOD:** - The work should be completed within **6 Months** from the date of receipt of the LOI/VO.
10. **GST:** - The prevailing rates of the GST will be applicable to this order.
11. **BILLS:** -You will have to submit the bills in triplicate to this office as per the specifications mentioned in Schedule 'A'. The bills submitted should be in the name of Office of the **Executive Engineer, EHV O&M Division Karad (GST No.27AAECM2936N1Z2)** at EHV O&M Dn Karad.

After duly recorded by the concerned S/Stn Incharge, the same will be reflected subject to availability of funds at Division office. Please quote your GST No. & SAC Code for the Service availed by you on bill for smooth payment.

**12. PAYMENT:** - 100% payment against the bills for the work actually carried out will be given to you after deducting necessary taxes & duties as per Govt. Rule either by cheque or NEFT/RTGS.

**13. PENALTY:** -

**A. Minimum 3KM earth wire should be replaced in one outage period i.e. 8 hrs. or in its proportion** as per directives of operating officer; failing to which the penalty @ 1% per delayed hour of that instance bill will be imposed.

**B.** If work of replacement of earth wire is carried out less than 3KM in one outage period i.e 8 hrs. or not in proportion, then penalty at the rate 2% per meter of remaining quantity that instance bill will be imposed.

**C. Non-attending the work:** - If you have non-attending work after approved outage due to non-availability of manpower then penalty will be imposed in respect of 5 % of that instance schedule work amount.

**14.** The work should be strictly executed as per the Schedule enclosed & as per instructions of the concerned authority assign by the Ex. Engineer or his representative deputed for this work.

**15. Taxes** as applicable will be deducted from your bill at source.

**16. DISCARDED OFFER CONDITIONS:** - The Company reserves to itself the right to reject any or all offers which does not confirm to any of the conditions.

**17. PRICE:** -The rates quoted should be firm & price variation will not be applicable at any cost.

**18. EXECUTION OF WORK:** - In the event of the offer being accepted in the whole, the successful contractor shall execute the order immediately as per the order schedule within the time specified in the work order.
