4. Quotations should be duly filled in all respect and signed, failing which it will be liable for rejection.
5. In case of any dispute, decision of the undersigned shall be final and binding on the contractor.
6. Taxes should be quoted distinctly, if any.
7. No material will be issued by the company for this work.

8. First & final bill should be submitted to this office after satisfactory completion of the work, for arranging payment. Statutory deductions such as TDS, GST-TDS will be made as applicable at the time of payment
9. The supplier shall provide guarantee/warranty for a period of 1 year from the date of successful supply and installation of the system. During this period any manufacturing defect or malfunction shall be rectified/replaced by the supplier free of cost
