Terms & Condition:-

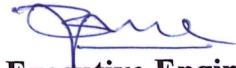

- 03) Security Deposit: The successful bidder will have to pay an amount equivalent to 5% of the contract value towards security deposit in this office.
- 04) Experience of one year is required for the vehicle.
- 05) All RTO documents accordingly should be in the name of Transport Company/ Agency/ Proprietor only. And also **required following documents:-**
 - a) **R.C. & T.C. books of the vehicles offered.**
 - b) **Fitness certificate of the vehicle.**
 - c) **Insurance certificate covering all types of risks.**
 - d) **Registration certificate / Route permit of transport contractor.**
 - e) **Pollution under control certificate.**
 - f) **PAN card**
 - g) **Driver having valid public driving license**

h) Vehicle should be in good condition with fitness certificate on or after 2020.
