With reference to above subject, you are requested to quote lowest possible rates for Annual rate contract for Repair/Rewinding and Alignment of various motors of HVDC receiving station Padghe for the year 2025-26 as per specification in Schedule – A with following terms and conditions.

TERMS AND CONDITIONS:

1. The EMD and Tender fees is to be paid online on the account of MSETCL through website <https://srmetender.mahatransco.in>. **Due Date- 27.10.2025 upto 10:00 Hrs.**
2. Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- Submit the performance /experience certificate for similar nature of works as per “Schedule-A” at any HVDC substation.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex.Engineer or equivalent. The bidder shall also submit the copy of the work order mentioned in the experience certificate as testimonials.

Commercial Bid.

- The bidder shall submit the copy of PAN card along with of Income Tax returns for the last three financial years, from the last day of month previous to the one in which Tenders are invited.
- The bidder should be registered under GST Act and submit the GST returns for the last Financial year from the last day of month previous to the one in which Tenders are

invited.

- The bidder should have a valid Electrical Contractor's License issued by the Government of Maharashtra for work of erection/commissioning of EHV equipment.
- Shop Act License.
- Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- Net Worth of last 1 year duly certified by Chartered Accountant should not be less than 25% of estimated cost.

3. The Contractor rates should be in percentage (%) based on estimate cost.

4. Rates should be valid for 120 days from the date of commercial opening of RFX.

5. Rfx fee is Rs.118/- including taxes (Is nonrefundable).

6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.

7. Income Tax will be deducted from contractor's bill, as per Govt. rules

8. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

9. Scope of work:-

Scope of work includes Repair/Rewinding and Alignment of various motors of HVDC receiving station Padghe for the year 2025-26.

a) 'The company' will hand over all the motors to the vendor in normal working/healthy condition and it will be the sole responsibility of the vendor to hand over all the motors and pumps in Healthy/Working condition after maintenance and Testing. Any component failure during the process of maintenance and alignment is to be replaced by the vendor free of cost.

b) Work completion certificate needs to be submitted with the bill.

c) Vendor must give warranty for 12 months from the date of Maintenance and Alignment.

d) Vendor must bring all T&P including Polish paper .CRC, Jelly etc. required for maintenance and alignment of various motors. No material will be provided by 'The Company'.

10. The contractor will have to enter into an agreement at his cost with 'The Company' in the prescribed pro forma – on Non Judicial bond paper / franking paper / Paper where payment is made to concerned authority of Govt. by e-transfer for registration – within 10 (Ten) working days from the receipt of the Letter intimating from the office of The Superintending Engineer, HVDC R S O & M Circle, MSETCL, Padgha.
11. You have to pay the security deposit of amount equal to 5%(Five) of the order value within

07 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (O&M) Circle, Padghe, Tal. Bhiwandi, Dist. Thane, Demand Draft or equivalent Govt. Securities or Fixed Deposit Receipt or RTGS.

For the offers received below the estimated cost of tender, the amount of Performance Bank Guarantee shall be applicable as under.
