Online bids are invited in two bid system for SRM enquiry in r/o supply of Self-support Aluminium ladder (ghoda shidi) with extension having size of 20ft x 35ft for Substations under EHV O&M Division, Pimpri Chinchwad, Pune **on or before 06.11.2025** on following Terms and Conditions: -

TERMS AND CONDITIONS

Submission of bid:

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <https://srmetender.mahatransco.in>

A. Techno –Commercial bid:

This should contain following valid documents certificates to be uploaded as a proof of qualifying pre-requisites, brochures, etc.

- 1.Scanned copy of EMD receipt. In case of EMD exemption shall submit an undertaking duly notarized stating that enterprise shall supply all the materials of intended work contract, manufactured from its own unit. Also the registration of Micro & small enterprises should be valid on the date of submission of bid & the validity of same should be verified by certified chartered accountant in practice.
2. Valid copy of PAN card.
3. Valid copy of GSTIN registration.
4. Income Tax Returns: The Bidder shall submit the copy of Income Tax returns for the last three financial year (i.e. FY 22-23, 23-24 & 24-25),

5. Valid shop act & establishment registration or NOC of Grampanchayat or Udyog Aadhaar certificate.

NOTE:-

1. The original colored scan copy should be uploaded as bid documents in support of Statutory Qualifying Criteria i.e. Statutory Licenses / Registration etc. The attested / notarized photo copies of the same will not be entertained.
2. In case if any point is not applicable, then please attach the document (Specify on the Letter head of the agency as “Not Applicable”).

If any of above document is not uploaded or found not as per TQR in techno commercial bid such bid will be rejected.

All General/Technical/Commercial Terms and conditions of the contract of the company are applicable to this contract.

B. Commercial bid: -

Bidder should upload the digitally signed price bid under commercial bid online.

1. Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tender fulfills the desired prerequisites; the Price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
2. This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
3. **The estimated rates given by this office are inclusive of all taxes. However, the bidder has to quote rates exclusive of all Taxes. The taxes have to be quoted separately along with HSN / SAC code (GST codes) for individual items & it is mandatory for all bidders**
4. The technical documents should be uploaded in the Technical bid & Commercial documents /offer/price bid should be uploaded separately. In case both Technical & Commercial bid are uploaded in one file wrongly, the offer will be rejected.
5. The offer shall be valid up to 120 days from the date of opening of the enquiry.

C. General Terms and Conditions

1. **AGREEMENT:** - Bidder will have to execute the agreement bond with the Executive Engineer, EHV O&M Division Pimpri Chinchwad, Pune on stamp paper of 500/- within 15 days from date of issue of LOI. The cost of stamp paper will be borne by the contractor. After submission of agreement, the contractor will be called for scheduling the date of signing & execution of

agreement in the office of Executive Engineer, EHV O&M Division, Pimpri Chinchwad, Pune. Until the agreement is executed, the MSETCL will not be liable to pay nor shall the bidder be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the bidder.

2. **SECURITY DEPOSITE:** - Bidder will have to pay **Security Deposit of 10% of the work order value** within 7 days from the date of issue of LOI in the form of FDR/B.G. of any Nationalized/ scheduled Bank in the favor of “MSETCL” at the office of The Executive Engineer, EHV O&M Dn Pimpri Chinchwad Pune, valid for one year or online payment NEFT/RTGS. If you fail to do so, the SD will be recovered from your first bill with interest as per SBI PLR 18%. The Security deposit will be refunded only after satisfactory completion of the guarantee period. Also, you will have to apply for refund of SD within 6 months after completion of guarantee period. If you fail to apply within stipulated period, the action as per CO’s rules will be taken.

Please note that, the % of SD Clause of the work order may vary as per rules & guidelines issued by MSETCL / Govt from time to time. Same will be binding on you. For the offers received below the estimated cost of enquiry, the amount of security deposit shall be applicable as under.

3. **SCOPE OF WORK ;** The scope of work includes for supply of Self-support Aluminium ladder (ghoda shidi) with extension having size of 20ft x 35ft for Substations under EHV O&M Division, Pimpri Chinchwad, Pune as per mentioned in Schedule A .

The detailed specifications of Self-support Aluminium ladder (ghoda shidi) with extension having size of 20ft x 35ft is as follows

- It should have 67mm strong side rails made up of high tensile aluminium alloy.
- It should have corrugated steps ensures anti slip surface & firm grip.
- It should have convenient extension & retraction of fly section.

- It should have aluminium slip resistant platform of 8” x 11” lifted at 3 ft from the top.
- It should have aluminum casted catcher which ensure firm grip. Lockable at every rung.
- It should prevent sway of the back section of the ladder while folded.
- Maximum work height should be 38 ft.

The material not confirming to the above specifications shall be rejected

4. **OPERATING OFFICER:** - The Additional Executive Engineer, Substation Maintenance Subdivision , Pimpri Chinchwad is hereby appointed as Engineer In Charge /Operating Officer for this work. The supply of material is to be carried out in presence of operating officer or his representative and up to his entire satisfaction.
5. **DELIVERY OF MATERIAL:** Material shall be delivered within 02 months from the date of receipt of order at S/Stn. as per schedule B under EHV O&M Pimpri Chinchwad Division, Pune. The supply of material is to be carried out in presence of operating officer or his representative and up to his entire satisfaction
6. **PERIOD OF CONTRACT:** The contract for the period of **12 Months** will be placed with the agency whose rates and offers are found suitable. **The undersigned however reserves the right to place the order for any shorter period and to terminate the order at any time if the services are not found satisfactory.**
7. **VALIDITY OF ENQUIRY:** -Enquiry shall remain open for acceptance for a period of 1 months from the date on which it is due for submission. During this period, no bidder shall be allowed to withdraw his enquiry. Any such withdrawal during the said period will entitle the forfeiture of the earnest money deposited by the bidders. As such the offer submitted by the bidder must have a **validity of minimum 120 days from the last date of submission of offer.**
8. **BIDDER’S QUOTATION:** **The estimated rates in Enquiry document are including of GST & Cess. However, the bidder should quote rates exclusive of all charges, Taxes, statutory charges, etc if any. The taxes should be quoted separately in the space provided in the SRM bidding system.**
9. **SUBMISSION OF ENQUIRY:** The enquiry should be submitted through SRM only. Bids submitted physically/ in hard copy will not be considered
10. **SUPPLY OF MATERIAL:**

Required material shall be supply immediately after the receiving of the order and as per the call from The Additional Executive Engineer, Substation Maintenance Subdivision, Pimpri Chinchwad. The material to be supplied shall be new & as per manufacturer standard make with guarantee of one year and should be inspected by concern substation incharge before starting the work.

If the quality of material/ spares is not found satisfactory, then said material is liable to be reject.

11. **GUARANTEE PERIOD:** The supplied material shall be guaranteed for period of 12 months from the final acceptance of the material by the Substation incharge. If the material supplied found defective due to bad design or workmanship that should be replaced by the contractor at free of cost immediately or otherwise same will be deducted from your bill/ S.D. All costs for the replacement of defective parts such as supply, transportation, etc. shall be to the account of the contractor.
12. **PENALTY:-** If you fail to supply the material within stipulated time as mentioned above, you will be liable to pay penalty @ 1/2% per week, maximum to 10% of order amount shall be levied on contract value.
13. Labour & T&P for the supply will be on your account. Required man power and machinery should be arranged by you
14. **PACKING/ HANDLING & TRANSPORTATION OF MATERIAL:** The contractor should be fully responsible for packing, forwarding & transportation of material by any other authorized mode of transport, clearance of equipment & further transportation of site place to work/ storage yard, etc. in respect of material in contractor's scope.
15. **PAYMENT OF TAX INVOICE:**
- Tax invoice in triplicate along with guarantee certificate and advance stamp receipt & completion report shall be submitted to The Additional Executive Engineer, Substation Maintenance Subdivision, Pimpri Chinchwad. Bank Details along with bill for RTGS/ NEFT Payment, PAN no., GST no. should be mentioned on Tax invoice/ E-invoice (if applicable).
- After receipt of Tax invoice, Scrutinizing & auditing will be done at Division Office and payment will be affected accordingly subject to availability of funds.
16. **INCOME TAX/ STATUTORY TAXES:-** Taxes will be applicable as per prevailing rate. Statutory deduction shall be made as applicable.
17. **SUB- LETTING OF CONTRACT:** The contract or any part thereof shall not be assigned, transferred, or sublet.
18. **FORCE MAJEURE:** Only the following conditions shall be considered for the purpose of this clause.
- a. Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc
 - b. Acts of any Government, Domestic or Foreign such as war (declared or undeclared) Priorities, Guarantees Embargoes etc.
 - c. The party affected by 'Force Measure' shall within 15 days of the occurrence of such a cause, notify the MSETCL in writing with sufficient documentary proof.
19. The insurance of your labor's will have to be done at your cost. If you failed to do so, any compensation or claim arising will be your responsibility.
20. **TERMINATION OF CONTRACT:** The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.

21. **APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:** All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding supply and work, which are not stated here, are also applicable to this contract.
22. The undersigned reserves the right to alter, modify or cancel the above order at any stage, if found necessary.
23. **JURIDICTION:** All disputes or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE Court only.
24. **ACCEPTANCE OF Enquiry:** The Company does not bind itself to accept the lowest or any tender/enquiry neither will any reason be assigned for the rejection of any tender/enquiry.
