# SECTION-I INVITATION FOR BID (IFB) (LOCAL COMPETETIVE BIDDING)

1. The Maharashtra State Electricity Transmission Company Limited Mumbai, herein after referred to as the 'Owner' (MSETCL) invites bids through SRM e-tendering system in TWO bids system (Techno- commercial Bid & Price Bid) from eligible bidders in India having suppiled Precast concrete material for "Empanelment of Manufacturer for various size of Precast concrete material for Cable Trench, Box Culvert, Retaining Wall, Compound Wall and Storm Water Drain of Substation".

### 2. Scope of Work:

## 3. Qualifying Requirement:

#### Compulsory Qualifying Documents to be submitted by bidder:

- 1. The bidder should be registered under GST. The Bidder shall submit the copy of GST returns of last 01 (One) year.
- 2. The bidder shall submit Statement of Net worth of last F.Y. ending 31st March of previous financial year for an amount not less than 50 Cr. The bidder should submit statement of Net worth duly certified by the Chartered Accountant. (with UDIN number)
- 3. The bidder shall have average annual financial turnover of Rs. 200 Cr. in the last three financial years for manufacturing of precast unit and same shall be certified by Chartered Accountant along with UDIN no.
- 4. Bidder has to submit the certificate of experience for supplying/execution of all precast concrete units viz. Cable Trench, Box Culvert, Retaining Wall, Compound Wall and Storm Water Drain of minimum of Rs.200 Cr. in Government organization as well as private sector duly signed by the officer not below the rank of Executive Engineer or equivalent in case of Government works or from authorised Authority of Private sector. In case of private sector, experience certificate along with copies of agreement of work and work orders mentioned in the certificate are essentially required.
- 5. The bidder should be registered under P.F. Act and shall submit EPF certificate along with Form 5A in applicable.

- 6. Income Tax return for last three financial years along with audited P&L A/c and Balance Sheet Copy.
- 7. Coloured Scanned Copy of Pan Card for the Firm.
- 8. Annexure G Undertaking to be submitted by the Bidder declaring that Bidder is not Debarred/Blacklisted by Government/Semi-Government/Other Power Utilities
- 9. Annexure I for authenticity of the documents submitted by the bidder on Rs. 500 non judicial stamp paper.

### Other Documents to be submitted by Bidder:

1. The bidders is required to furnish Bid Security Deposit of Rs. 50,000/- by online mode.

## 4. Important Instructions for Bid Submission:-

- 1. The proposals are to be submitted in two parts viz. Techno-commercial Bid and Price Bid.
- 2. Prepare your Techno-commercial Bid documents in accordance with the instructions provided in the tender documents.
- 3. The price should be quoted for each item mentioned in Annexure –B on a lump sum basis inclusive of all taxes and duties but exclusive of GST. The GST, as applicable shall be paid separately.
- 5. The General Terms and Conditions (GTC) are enclosed as Annexure A
- 6. The Technical specification are enclosed as Annexure C and agency has to confirm the same along with documentary evidence and attached with bid.

#### 7. General Points:-

- 1. The prices to be quoted against this IFB shall be in Indian Rupees only.
- 2. The empanelment of agencies will be treated as works contract in totality.
- 3. For Evaluation of the Tender, the total price of work excluding GST be considered.
- 4. Submission of bids with unrealistic rates, the MSETCL reserves the right to reject the bid summarily.
- 5. Price variation shall not be given. The price quoted by the bidders shall be FIRM throughout the period of contract including any extension thereof.
- 6. A complete set of documents can be downloaded by the bidder from MSETCL's SRM Etendering website <a href="https://srmetender.mahatransco.in">https://srmetender.mahatransco.in</a> The cost of bidding documents should be paid online before the date of bid submission and the screen shot of successful payment transaction shall be uploaded with bid documents being submitted by the bidder.
- 7. The rates shall be finalized on Lowest of quoted price of qualified bidders, exclusive of GST. MSETCL reserves the right to derive prices for empanelment based on market research, industry standards, and other relevant factors. These derived prices may be used as a reference point or benchmark during the evaluation process. MSETCL retains the discretion to accept or reject bids based on the derived prices and other evaluation criteria outlined in the tender documents. Bidders are advised to consider this clause when submitting their proposals.

- 8. Based on terms & conditions of this tender the field officials will place a work order at derived prices, as & when required.
- 9. Bidders will be required to agree to the finalized rates for empanelment. Only these empaneled agencies will be considered for awarding work as needed.
- 10. If any agency declines to take up the work, they will be delisted from the empanelment list for six months from the date of denial.
- 11. 100% GST payment shall be made against invoice submission. All other provisions of the tender remain in full force and effect, other than any provision that conflicts with the terms and spirit of this tender, which shall be deemed to be amended appropriately in order to be consistent with clause.
- 12. It may please be noted that the taxes / duties will be paid / reimbursed as per actual OR as stated in price break-up statement whichever is lower on submission of valid documentary proof. In case of any variation in statutory taxes/duties/levy or any new existing tax/duty/levy is revoked by the Government, the same shall be passed through either side. In certain cases production of valid documentary proof may be brought for.

- 8.2 The contractor should submit their bids online well in advance within the due date & time. The scan copy in respect of online payment of EMD and SRM E-tender fees should be submitted online along with the bid.
- 8.3 The undersigned reserves the right to cancel any or all the SRM E-tender at any stage without assigning reasons thereof.
- 8.4 All other General Terms & Conditions as per standard specification of MSETCL are applicable to this SRM E-tender.
