TERMS AND CONDITIONS:

- 1. The quotation must be submitted in sealed envelope duly super scribed with all details as mentioned below-

- 2. The offer should be submitted in two separate sealed envelopes contained in one main envelope super scribing the subject.
  - Envelope 1: Documents required: following documents duly attested & signed by agency. (Copies should be clearly readable)
  - a) Copy of vaild Shop act/udyog Adhar/Udyam registration
  - b) GST Registration certificate (If not applicable Certificate/ Undertaking for non applicabilty)
  - c) Copy of PAN card of the agency/owner of the agency
  - d) Experience certificate or similar type work experience

All the documents of this enquiry Schedule & above accompanying documents shall bear the authorized signature of the Bidder, failing which the offer will be liable for rejection. The decision in this regard will be taken by undersigned.

- Envelope 2: Price bid documents: This should contain only price bid in given table, not in any other format. After verifying full documents /certificated pre-qualification as above in envelope 1, if it is found that, bidder fulfills the desired prerequisites, envelope 2 will be opened. If the same is not meeting the prerequisites, Envelope 2 shall not be opened.
- 3. Due Date: -

The quotations complete in all respects, should be submitted to this office on or before 19.11.2025 up to 14:00 Hrs positively.

**Quotation Opening Date: -**

The all quotations will be tentatively opened on dt. 19.11.2025 at 17:00 Hrs, if possible or suitable date & time as per availability of concern officials of MSETCL.

4. Quoted Rate: -

a) The rates should be quoted on firm quotation basis as pe mentioned in schedule attached.

- b) The price quoted by you in your quotation for the supply of material shall be inclusive of Labour welfare cess, F&I, packing, insurance and transporation etc.
- c) The applicability of GST or otherwise should be clearly mentioned in offer, otherwise rate should be considered including GST.
- d) The rates offer should be valid for at least 60 days from the last date of receipt of quotation.
- e) While quoting the rates, the taxes if any, should be mentioned clearly.
- f) Taxes/cess as pplicable will be deducted from bill as per prevailing rules.
- 5. **Order Value:** The final order value will be limited to Rs. 72,223.08/- Only (In word:Seventy Two Thousand Two Hundred Twenty Three only) (Inclusive all taxes, duties & cess)
- 6. **Signing of Contract**:-Within 7 days from date of the receipt of work order/LOI the contractor/ agency will have to execute an agreement as per provision of "Mumbai Mudarank adhiniam 1958 CL.34" with requisite stamp duty (Stamp paper not less than Rs. 500/-) before starting of work.
- 7. Security Deposit: The successful bidder will have to deposit the security deposit of 5% of the work order value in cash/FDR within 7 days from the date of receipt of LOA/ work order at the Office of the M/s Chief Engineer, CAFS, Nashik Zone MSETCL. The entire security deposit will be refunded to you on satisfactory completion of contract period and as per avaibility of fund. In case break of contract from your side, before completion of contract period, the security deposit will be forfeited by the company
- 8. You have to submit "All risk cover Policy" issued only by Director of insurance to this office before execution of work otherwise 0.5% of contract value will be deducted from bill.
- 9. **Period of completion:** The work should be completed within 3 months from date of handing over of site.
- 10. **Scope of work:** You will have to execute the above work as per the scope of work given in Schedule. You will have to execute the works in presence of concerned MSETCL Engineer.
- 11. **Penalty:** If the work is not completed within stipulated period the penalty @ % per week subject to maximum 10% of the order value of work will be levied.
- 12. **Quality of work & material:** You will be responsible for quality of work & workmanship. The material used to be strictly as per MSETCL specification & should be got approved before starting the work from undersigned or his representative.
- 13. No claim for compensation for delay in starting of work: No compensation shall be allowed for delay caused in the starting of the work on account of non availability of outages due to any reasons.
- 14. **Inspection by our representative:** The concerned Engineer incharge will be free to visit the contractors woricas & when required at any time.
- · 15. Tools & plants: All tools plants & machinery required will have to be arranged by you at your cost.
- 16. Technical skilled persons: The contractor shall depute skilled workman for each class work.
- 17. **Stacking of material:** The material will be stacked at one place, you should take all precautions for watch & ward. Also, the replaced material, if any, may be handed over to concern S/Dn Incharge.
- 18. **Precaution:** All substation's Control panels will be in charged condition no outage will be granted for the subjected work. The contractor should take all precautions at his own cost until handing over the site to the MSETCL.
- 19. Accident: If any accident occurs to your labours, skilled or unskilled, compensation if any is to be paid by you only. The contractor shall be responsible to abide all prevailing labour including Workmen's Compensation Act
- 20. Crossing of contract value: The contractor will have to watch & ensure that, the total value of work carried out by him does not exceed the contract value. If the work / value of contract is likely to be

exceeded, the same should be brought to the notice of under signed in writing in such case he is not permitted to do the work without permission of undersigned.

- 21. First Aid Box: The contractor should always keep & maintain. First Aid Box for this work as safety measure.
- 22. **Permission of work:** Prior permission should be obtained before starting the work from concerned engineer in charge, in connection with shut down area is declared as prohibited area by Govt. It is necessary to give the names of workers to concern Incharge & same should be got approved. The concern S/S Incharge is fully empowered for giving or refusing the permission for entrance in the S/Stn area in exigencies.
- 23. **Failure to execute the work:** If the work is not executed in the stipulated period the MSETCL shall be at liberty without further notice or reminder to the contractor, to get the same work done from any other agency at risk of contractor & prefer a claim for difference in price.
- 24. **Payment Schedule:** 100% Payment will be done after successful completion/commission of 100% work & against the submission of bill & subject to the availability of the funds.
- 25. Bill: Tenderer will have to submit single bill in triplicate copy along with all relevant documents such as MOM/Service Report/JMC, Guarantee certificate etc to concerned Engineer Incharge. The concerned Engineer Incharge will verify & certify & submit the same to this office for SES/MIGO & send to CAFS Unit, MSETCL, Nashik zone for auditing & payment.
- 26. In case of difference of opinion, about interpretation of terms & conditions between Owner/Agency & MSETCL, the decision of order placing authority will be final & binding on the Owner / Agency. Also, any dispute arising out of your contract, it will be in the jurisdiction of Hon. Ahilyanagar court only.
- 27. Damage to Persons & Property: Tenderer will indemnify the MSETCL against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work During execution of work any damage/loss to Transmission Company's property occurs will be recovered from your bill. The indemnity bond on Rs 100/-stamp paper should be submitted to this office before executing the order.
- 28. Condition of contract: The contract is governed by the MSETCL general condition of contract.
- 29. Undersigned reserves the right to reject any or all the quotations without assigning any reason thereof. Also reserves rights to add or delete terms during the contract period if found necessary.
- 30. All other terms & conditions mentioned in tender document will applicable to this order.
