

E-Enquiry

Subject :- E-enquiry for Material required for Work of Charging and Pre-commissioning testing of 2 nos of Main-2 Line differential Relays at 220kV Khed City S/S end and 765kV Shikrapur PGCIL end, Pune.

Dear Sir,

Sealed & super scribed quotations are invited, for Material required for Work of Charging and Pre-commissioning testing of 2 nos of Main-2 Line differential Relays at 220kV Khed City S/S end 765kV Shikrapur PGCIL end under Package-A Pune as per 'Schedule A' as to reach this office on or before dt.18.11.2025 up to 15:00 hrs under this office on following terms & conditions: -

TERMS AND CONDITIONS: -

1. Rates shall be quoted as per the Schedule "A". Any changes must be brought out clearly.

2. SCOPE OF CONTRACT

The scope of work will be broadly as under:

Material required for Work of Charging and Pre-commissioning testing of 2 nos of Main-2 Line differential Relays at 220kV Khed City S/S end 765kV Shikrapur PGCIL end under Package-A as per the Schedule "A".

- 3. A separate sealed envelope containing Xerox copies of qualifying documents as below is to be submitted mentioning on the top of the envelop <u>"TECHNICAL BID"</u>:
 - i) Shop Act/ Udyog Adhar License/NOC of gram panchayat for shop. The NOC of gram panchayat should be valid and recent one.
 - ii) PAN Card.
 - iii) GST Registration
 - iv) Copy of valid electrical contractor license.
 - v) Work experience certificate of similar type of works.

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

4.The rates should be quoted on your firm letter head as per 'Schedule A' in sealed separate envelop mentioning on top of envelop "COMMERCIAL BID"

Techno-commercial bid will be opened for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for qualifying per-requisites as mentioned above, if it is found that, the tenderer fulfills the desired per-requisites; the price bid will be opened. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. will be liable for rejection.

- 5. Contractor shall ensure that the procurement of material should be as per MSETCL standards, and as per Schedule A.
- 6. Both envelops, should be kept in another big envelop mentioning "Material required for Work of Charging and Pre-commissioning testing of 2 nos of Main-2 Line differential Relays at 220kV Khed City S/S end 765kV Shikrapur PGCIL end under Package-A".
- 7. 100% payment will be effected by this office by NEFT/online after completion of work as per required specifications within 45 days after the submission of complete bill in all respect in Triplicate with all necessary documents.
- 8. **Security Deposit:** You have to Pay, Security Deposit @ of 10% of the total value of the order in this office in online/by D.D./ B.G./ fixed deposit in nationalized or scheduled bank in favor of Executive Engineer, EHV Project Division-II, Pune after receipt of LOI within 7 days. Also, you will have to apply for refund of SD within 6 months after completion of guarantee period if any. If you fail to apply within stipulated period, action as per company's rules will taken.
- 9. The work shall be under the supervision of the Addl. Executive Engineer, EHV s/s Project Chinchwad Pune or his representative.
- 10. The estimated rates given by this office are inclusive of taxes. However, the bidder should quote rates exclusive of all Taxes. The taxes should be quoted separately.
- 11. The work as per 'Schedule A' should be completed within 1 month from the date of site handover/LOI/W.O. This work is done in view of charging bays immediately.

12. Penalty:

- (a) **Delay in execution of work:** If the contractor fails to complete the total work in all respect in stipulated time as mentioned above, he will be liable to pay penalty at rate of $\frac{1}{2}$ % per week subject to maximum limit of 10% of the total value of the order.
- (b) **Performance of work:** If it is found that performance of work is unsatisfactory, the contract is liable for termination without giving any prior notice and at your entire risk. The security deposit paid by you shall be forfeited.

- (c) **Delay in starting the work**: If it is found that the agency fails to execute the agreement/ start the work within stipulated time period, the contract is liable for termination without giving any prior notice and at your entire risk. The SD paid by you shall be forfeited.
- 13. Any breakage/damage occurred to MSETCL material/ Equipment / theft of material if any, asset during the supply shall be recovered from your bills as per rules.
- 14. Quantity mentioned in Schedule 'A' are tentative & payment will be made on the basis of actual quantities executed by you.
- 15. **Guarantee Period:** The material supplied must be guaranteed/ warranty against quality of material used for 12 months from the date of completion of work. If something found wrong/ any defect is traced also regarding your workmanship/ material during this period the same has to be rectified by you free of cost immediately.
- 16. **Specification:** The work will have to carried out strictly as per specification & to the fullest satisfaction of the undersigned or his authorized representative.
- 17. Any type of damage occurred during the execution of work due to bad workmanship the contractor has to make it good and the cost of the same will be on contractor's account.
- 18. **Workmen's Compensation Under Act 1923 (VII of 1923):** You will be responsible for & will pay any compensation to your workmen under Workmen's Compensation Act 1923 for injuries caused to your workmen.
- 19. All General /Technical / Commercial terms and conditions of the contract of the MSETCL Company are applicable to this contract.
- 20. The contractor shall not be entitled to claim any interest on amount payable to him.
- 21. You shall not entrust the work on sub-contract /transfer or assign the contract or any part thereof to any third party. In case any deviations observed it will be treated as breach of contract and the contract will be terminated at your entire risk and cost.
- 22. You should be fully aware of the MSETCL's General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
- 23. You will have to arrange for insurance at your cost for the men, material vehicle etc. associated with the contract till the work is satisfactorily completed. The company will not be responsible for any accident or loss, damage, theft, mishap. You will have to lodge, pursue & settle any or all such claims through Insurance Co. without involving MSETCL in the process.
- 24. **Income tax**: If applicable will be deducted as per rules/ otherwise you will have to submit income tax exemption certificate or income tax registration no. of your firm PAN No.
- 25. In case of difference of opinion, misinterpretation of any of the condition of the contract. In connection with or arising out of the condition or during the period work, the decision of the under signed shall be final & binding on you.

- 26. The work is to be carried out in presence of the Operating Officer or his representative and up to his entire satisfaction. It is necessary to carry out the Joint Measurements by both parties, i.e., by your office Service Engineer & by the Operating officer.
- 27. Labour, T & P for the work will be on contractor account & required man power as well as machinery should be arranged by you.
- 28. While execution of work, if any loss is caused to MSETCL, the same will be recover from you & you will have to make good the loss, work to be attended by you at your cost & risk only.
- 29. **Accident:** The contractor shall ensure the safety of all the workmen, materials and equipment at work site. The contractor shall be responsible for providing of all safety notices and safety equipment required. If any accident occurs to any person, labour skilled or unskilled, compensation if any is to be paid by the contractor only.
- 30. **Jurisdiction:** All disputes, differences related to the contract shall be subject to the exclusive jurisdiction of Pune District Court.
- 31. The persons engaged by you must be well trained for above work.
- 32. No other charges except Schedule A, will be borne by the MSETCL.
- 33. The workers employed by you for the above work shall not be entitled for any facility/claim from MSETCL what so ever.

- 35. **Agreement:** As per order value you have to enter into contract agreement on stamp paper as per Stamp Act Amendment dt. 14.10.2024 for this contract within 07 days from receipt of LOI, the cost of stamp paper to be borne by you.
