4. Payments will be made in R.A. bills or only first and final bill at the discretion of Engineer in charge as per availability of funds.
- ✓ 5. Our rates are inclusive of all GST will be recovered from your bill as per Government rules at prevailing rates.
- ✓ 6. Rates quoted should be inclusive of all taxex T & P labour etc.
